REQUIREMENTS FOR VERIFICATION OF FIRE ALARM SYSTEMS IN THE CITY OF VANCOUVER

Article 3.2.4.5. of the Vancouver Building By-law requires that installation of fire alarm systems in buildings must conform to ULC Standard S-524. This article also states that upon completion of the installation, each fire alarm system must be verified to ensure its satisfactory performance. This procedure must be done in conformance with ULC Standard S-537.

- 3.2.4.5.(1) Fire alarm and voice communication systems shall be installed in conformance with CAN/ULC-S524-M "Standard for the Installation of Fire Alarm Systems".
- (2) Fire alarm systems shall be tested in conformance with CAN/ULC-S537-M. "Standard for the Verification of Fire Alarm Systems", to ensure satisfactory operation.

ULC-S537 provides requirements for a verification procedure and for a verification report. The preface of this Standard indicates that the verification procedure described therein must be conducted by an organization other than the installing contractor and that the verification must be carried out by qualified personnel in the employ of an organization acceptable to the authority having jurisdiction. Clause 3.1.1 of this standard states that the conformance of the fire alarm system components with installation requirements of ULC S-524 must be included in the verification procedure.

These requirements of the CAN/ULC S-537 mean that qualified persons involved in a verification procedure must have sufficient technical knowledge of fire alarm system components, their function and performance, and must have necessary electrical qualification for evaluating conformance of these devices with installation provisions mandated by the ULC S-524 and Section 32 of the Canadian Electrical Code, Part 1.

The following acceptance criteria have been established by the City of Vancouver for organizations involved in verification of fire alarm systems:

1. A qualified person(s) employed by a ULC listed manufacturer of a FAS (i.e. qualified persons employed by Simplex, Edwards, Honeywell, Mircom, Notifier, etc.). Presently (in accordance with section 4(1)(e) of the BC Electrical Safety Regulation) employees of an electrical equipment manufacturer are deemed to be "qualified" for the purpose of doing electrical work of "commissioning" of the equipment supplied by that manufacturer.

Notes:

- a) Acceptance of technicians employed by these manufacturers is based on the fact that these technicians have respective factory training and relevant electrical qualifications.
 - b) Manufacturers must provide the City Electrician with detailed substantiation in this regard.
2. A Professional Electrical or Fire Protection Engineer (P.Eng) registered with the APEGBC.

3. A Certified Technologist (ASc.T) registered with the ASTT BC in the Electrical Technology area who in addition has successfully completed a full set of the CFAA courses for verification of fire alarm systems.
4. A qualified person employed by a fire alarm service company, provided this person possesses sufficient documentation indicating a successful completion of relevant factory training on fire alarm equipment and possesses a provincial certificate of qualification to do electrical work on alarm systems.

Note: The following criteria is provided by the BCSA

"The current Electrical Safety Regulation permits the following qualified persons, that are the holder of a valid Certificate of Qualification (C of Q), perform electrical work on fire alarm systems;

- *C of Q in the trade of Electrician,*
- *C of Q Restricted Class 'C' or*
- *C of Q Restricted class Alarm & Communication class 'AC'".*

Definitions:

1. A qualified person is deemed to be a person in the employ of the verification organization (proof of qualification-training courses and relevant fire alarm and electrical certificates, etc., is required).
2. A Professional Engineer is deemed to be Electrical or Fire Protection Engineer registered with the Association of Professional Engineers and Geoscientists of the Province of British Columbia (APEGBC), who is not involved in the installation of the fire alarm system subjected to this engineer's verification.

Notes:

- a) All verification reports are permitted to be signed only by qualified persons employed by verification organizations accepted by the City of Vancouver for this purpose, as per list of acceptable verification organizations. (Attached is the latest list of Acceptable Verification Organizations and Qualified Personnel. This attachment will be periodically updated to reflect new additions or modifications to the list.
- b) Fire Alarm System Verification Report Form (Appendix C form of ULC S537) has been amended for use in the City of Vancouver. This form is shown on Attachment 1 to Bulletin 2000-021-EL.
- c) When a F.A.S. is connected to an acceptable central station (see Bulletin 2000-019-EL), a ULC Certificate "Central Station Fire Protective Signalling Service" must be completed as a part of the verification report. A sample of the Certificate is shown on Attachment 2 to Bulletin 2000-021-EL.
