RE: Open House - Clarendon Extension and Nearby Street Design Proposals

The City of Vancouver is preparing to complete the street network in the vicinity of Clarendon Street and 34th Avenue. The City has acquired the properties between 33rd and 34th Avenues in order to build an extension of Clarendon Street through to 33rd Avenue (Clarendon Connector). Traffic and transit buses destined to/from Clarendon Street currently travel on local neighbourhood streets such as 34th Avenue and Nanaimo Street south of 33rd Avenue. This is a result of Clarendon Street not connecting through to 33rd Avenue. At this time, staff would like to discuss the details of completing the Clarendon Connector with the local community.

You may have already participated in the Norquay Village Neighbourhood Centre Program, attending workshops to discuss Traffic, Transit and Pedestrians, Kingsway Streetscape, Greening and Linkages, Housing Character and Parks. Based on feedback from these workshops, Engineering Services staff has prepared designs for a number of street improvements for key locations identified in the community, including Clarendon Street. The City of Vancouver is distributing this letter to inform the community that an Open House will be held to present designs and invite comments. Your feedback is important; please attend.
