**REPORT REFERENCE**

**1. Landfill Fire Update**

Tom Timm, General Manager, Engineering Services, introduced Lynn Belanger, Manager, Landfill and Transfer Operations, who provided an update on the fire in the demolition area at the Vancouver Landfill. Ms. Belanger reviewed the background and chronology of events, extinguishment strategy employed, and estimated costs. She noted the fire appeared to be out, however monitoring will continue and the final plan will depend on monitoring results.

Staff also put forward a recommendation for funding approval for Council's consideration, as set out in a Memorandum from the General Manager of Engineering Services dated February 17, 2009.

WHEREAS in November 2006, Council established several "Type A" and "Type B" advisory committees with terms that expired on December 7, 2008 to coincide with that Council's term of office. Since their establishment, these advisory committees have undertaken valuable work and provided important advice on policy matters to Council that have materially improved Vancouver's quality of life.

AND WHEREAS the "rolling together" of several previously existing committees into two larger committees - Advisory Committee on Access and Inclusion and Advisory Committee on Diversity - has not guaranteed representation for each community these committees seek to represent, nor has it proved an optimal situation for advancing the issues of individual communities.

AND WHEREAS the City created a Women's Task Force in 2004 that developed a Gender Equality Strategy that has not been implemented.

AND WHEREAS many advisory committees continue to express confusion about their roles, responsibilities and rights.

THEREFORE BE IT RESOLVED

- A. THAT Council establish the following Type A committees as advisory to Council and that their mandates and terms of reference remain unchanged:

  - Food Policy Council
- B. THAT Council establish the following Type A committees as advisory to Council and that their terms of reference and size be established as follows:

## 6. Building Affordable and Rental Housing

MOVED by Councillor Louie

SECONDED by Councillor Meggs

WHEREAS buying a home in the City of Vancouver requires an annual family income that is at least double what most families earn in this city; and

WHEREAS a sufficient stock of affordable rental and market housing is necessary for the social, economic and environmental sustainability of the city; and

WHEREAS private sector developers have indicated a strong willingness to work with the City to find solutions to the challenge of creating rental and affordable market housing; and

WHEREAS City action to support private sector investment in the generation of this kind of housing will help the city's economy and lay the foundation for long-term benefits to citizens; and

WHEREAS Vancouver should be a leader in the development of innovative programs to accelerate the construction of affordable housing, both for rental and home ownership;

THEREFORE BE IT FURTHER RESOLVED THAT:

1. Council ask the Mayor to convene as soon as practicable, a round-table consultation engaging City staff with housing specialists, developers, real estate consultants, architects and designers, neighbourhood leaders and other stakeholders to seek their advice and input on, but not limited to:
  - Short-term measures by which the City can increase the stock of rental and affordable housing;
  - elements of a longer-term strategy that builds on or reshapes existing initiatives;
  - prioritizing and streamlining the development permit processing of rental housing applications;
  - new initiatives, including consideration of incentives, to create new rental and affordable housing stock;
  - encouraging these new developments at or near rapid transit station locations.
2. Council direct staff to report back to Council as soon as possible following the round table consultation on methods to increase the supply of rental housing in the immediate term;
3. Council direct staff to report back to Council by the end of September 2009 on the state of rental and affordable housing in the city, including need, existing affordable housing, and the City's role in the development, operation and funding of affordable housing in the city, as well as affordable housing strategies now being employed in other municipalities, especially those championed by SmartGrowth BC;
4. Council direct staff to report back to Council, by the end of March 2009, on additional measures to protect existing rental housing stock.
