**1. TEXT AMENDMENT: Metro Core Jobs and Economy Land Use Plan - Downtown Policies**

An application by the Director of Planning was considered as follows:

Summary: To amend the Downtown Official Development Plan (DODP) and HA-3 (Yaletown Historic Area) District Schedule to accommodate future job space in the Downtown, and to maintain the commercial mix of historic Yaletown.

The Director of Planning, in consultation with the General Manager of Engineering Services, recommended approval, subject to the conditions as set out in the Agenda of the Public Hearing.

Also before Council was a memorandum dated April 20, 2009, from Kevin McNaney, Senior Central Area Planner, submitting the following additional recommendation for consideration:

- D. THAT the "DODP Rezoning Policy: Central Business District and CBD Shoulder", set out in Appendix C to Policy Report: "*Metro Core Jobs and Economy Land Use Plan - Part One: Proposed Downtown Policies*", dated October 16, 2008, be amended by adding the bold italicized text to the following section:

- 5.2(c) The site is contiguous and does not span roads or lanes. *Where Engineering Services is prepared to consider the closure and/or relocation of a lane, site assembly may occur across an existing lane.*

### Staff Opening Comments

Brent Toderian, Director of Planning, and Kevin McNaney, Senior Planner, Central Area Planning, provided an overview of the application, and along with Trish French, Assistant Director, Current Planning, and Lon LaClaire, Strategic Transportation Planning Engineer, Engineering Services, responded to questions from Council.
