THAT the Committee recommend to Council

- A. THAT Council adopt the Cambie Corridor Plan for Phase Two (Appendix A of the Policy Report dated April 19, 2011, entitled, "Cambie Corridor Planning Program - Phase Two") with the following additions:
 - (i) for sites immediately adjacent to the intersection of Cambie Street and 41st Avenue, staff may investigate further allowing mixed-use buildings beyond the anticipated 12 storeys, to be evaluated at each rezoning in the context of the principles enumerated in this plan, as part of future planning and community consultation in Phase 3. Investigation of the eventual supportable height in future planning work must consider, at a minimum, the following:
 - potential impacts on existing and anticipated development on the surrounding area as identified in Phase 3; and

- determination of appropriate relationships between mid-rise and potential tower building forms along Cambie Street.
- (ii) that the "rezoning application requirements" in chapter 11, specifically section 11.2.8 regarding a requirement for a green building strategy, be amended by adding the sentence: "The Strategy should include a deconstruction strategy relating to demolition waste".
 - (iii) that a 12th point be added on page 60 of the report that reads "the drawings that follow provide urban design detail and can be altered to improve design performance in conjunction with community concern".
 - (iv) that section 4.3 of the Cambie Corridor Plan be amended to consider opportunities to integrate small scale locally serving commercial space focused around a potential new station at 33rd Avenue, considering the relationship to the park and surrounding neighbourhood.
- B. THAT staff proceed with the implementation of the Cambie Corridor Plan, including the development of:
- (i) a detailed public realm plan including a financing and implementation strategy;
 - (ii) a district energy strategy including a financing and implementation strategy;
 - (iii) a utility servicing strategy that explores alternative ways to finance required servicing upgrades equitably across the Corridor, and
 - (iv) a comprehensive public benefits strategy including financing mechanisms, including the exploration of a density bonus zoning system to achieve public benefits and amenities, with a particular emphasis on affordable housing, as described within the staff report.
- C. THAT Council instruct staff to report back on any consequential amendments to other relevant policies required as a result of adoption of the Cambie Corridor Plan for Phase Two, including amendments to existing rezoning and public benefits policy.
- D. THAT Council repeal the Cambie Corridor Interim Rezoning Policy (2010).
- E. THAT Phase Three of the Cambie Corridor Planning Program proceed, coordinated and integrated with other community planning exercises.

1. Pursuant to Section 119(3) of the *School Act*, the Province of British Columbia in each year levies a tax on the net taxable value of all land and improvements in the City of Vancouver;
2. By *Orders in Council No. 148 and 149* approved on April 28, 2011, the Administrator in Council levied the following tax rates on Class 1 Residential, Class 5 Light Industry, and Class 6 Business & Other:

being dollars of tax for each one thousand dollars of taxable value, for the 2011 taxation year, which when applied to the net taxable value of all land and improvements in the respective Classes in the City of Vancouver would raise the following sums:

3. Pursuant to provisions of the *Vancouver Charter*, on March 15, 2011, Council approved By-law No. 10229 which authorized adjustment of the net taxable value of land in Class 1 Residential, Class 5 Light Industry, and Class 6 Business & Other in the City of Vancouver;

4. Pursuant to By-law No. 10229, the net taxable value and the adjusted taxable value of land in the above-noted Classes subject to taxation under the *School Act* for the year 2011 are as follows:

2. By *South Coast British Columbia Transportation Authority 2011 Property Tax By-law No. 71-2011* and *Replacement Tax By-law No. 72-2011*, Translink levied the following tax rates on Class 1 Residential, Class 5 Light Industry, and Class 6 Business & Other:
