DRUG TESTING CONSENT FORM AND WAIVER OF LIABILITY

PLEASE READ THIS FORM CAREFULLY.

In order to participate as a competitor in this [DESCRIBE THE EVENT, INCLUDING DATE] event (the "Event"), I, the undersigned athlete (the "Competitor"), hereby agree to comply with and be bound by the VAC's Anti-Doping Rules (the "Anti-Doping Rules").

I further agree to cooperate fully with \_\_\_\_\_ (the "Event Organizer") and the VAC and all their respective officers, officials, commissioners, employees, agents, volunteers and any medical, laboratory and drug testing personnel, agents or representatives designated by the VAC or the Event Organizer to conduct any drug tests of any competitors in the Event (the "Drug Testing Personnel"). I understand, accept and agree to the following conditions of my participation in the Event:

1. I hereby freely and voluntarily consent to the VAC or the Event Organizer conducting or causing to be conducted a random or targeted drug test in respect of my competing in the Event. A copy of the Anti-Doping Rules has been provided to me and I freely and voluntarily consent to be bound by the Anti-Doping Rules in respect of my participation in the Event.
2. I will submit a urine sample, without undue delay, if so required or requested, and will cooperate fully with any Drug Testing Personnel of the VAC or the Event Organizer.
3. I hereby authorize the VAC or the Event Organizer to have such urine sample tested by a medical laboratory approved or designated by the VAC or the Event Organizer for the presence of any prohibited drugs or substances, pursuant to the Anti-Doping Rules (a "Prohibited Substance"). I hereby authorize any physician, laboratory, hospital or medical professional designated, approved or retained by the VAC or the Event Organizer for testing purposes to conduct such testing and to provide the results to the VAC or the Event Organizer.
4. That if I am found to be in breach of any Anti-Doping Rules, I will respect and abide by the relevant rules and regulations governing results management of the VAC (including the Anti-Doping Rules) or \_\_\_\_\_ [the name of body or association governing the Event], and I understand that consequences of a breach of such rules may include (a) disqualification of the result obtained at the Event and/or (b) the imposition of a fine and/or suspension, as determined by the VAC in its lawful discretion pursuant to section 2.8(9) of the Vancouver Athletic Commission By-law No. 2875, as amended.
5. I understand that the failure to supply a urine sample, refusing to submit to a drug test, tampering with the sample or falsifying any information obtained in connection with the drug test will result in an immediate suspension, disqualification and forfeiture of any purses, prizes or compensation which I would have earned or would have been entitled to as a competitor in the Event.

6. I agree to waive any and all claims I may now or in the future have against and release from liability the VAC, the City of Vancouver and their respective officers, officials, commissioners, employees, agents, volunteers or any Drug Testing Personnel (the "Released Parties") in connection with any drug testing conducted, including for any personal injury, damages, expenses or less sustained by me as a result of any drug testing due to any cause whatsoever, including without limitation negligence or breach of any statutory duty on the part of any of the Released Parties.
7. I accept sole responsibility to remain current with all rules and regulations governing the Event, including without limitation all of the World Anti-Doping Code.

8. I do hereby declare and make oath that I am competing in this Event free from any Prohibited Substances.
9. I understand and agree that a positive or negative test result for any Prohibited Substances and/or a failure to comply in full with the Anti-Doping Rules may lead to the publication of my name by the VAC or any of the Released Parties, as well as other information the scope of which will be determined by the VAC in its absolute discretion. I hereby consent to the disclosure of all such personal and/or medical information by the VAC.
