CITY MANAGER'S COMMENTS

The City Manager submits the foregoing for INFORMATION.

PURPOSE

To provide Vancouver City Council with a report on the activities of the Vancouver City Planning Commission for the period 2007-2008.

BACKGROUND

The Vancouver City Planning Commission (the Commission) was established by Council to assist Council in an advisory capacity by considering and submitting reports to City Council on matters relating to the planning and development of the City, including:

- (a) representing ideas and opinions about the future of the city, as citizens of the City of Vancouver, and
- (b) considering and reporting to Council on any proposal likely to have a significant effect on the future of the City.

SUMMARY

The Commission carried out a work plan covering the duration of its 2-year term with the theme of "Vancouver: A City Built for Change." The core idea that emerged from the Commission's work on change and urban resilience is that a longer-term view of adaptability and a reasoned response to change need to be embedded in city design.

During this period, the Commission also provided comment to Council and heard presentations from speakers seeking to address the Commission.

DISCUSSION

The "Vancouver: A City Built for Change" program provided the framework for the Commission's work during this period. The Commission set out to examine the City's resilience in the face of change by asking the following questions:

- How ready is Vancouver for new societal, economic and environmental issues?
- How can Vancouver encourage innovation and go beyond what is already being done?
- What does adaptability mean for the development of buildings and the public realm?
- What are the principles and guidelines for adaptability?
- How does Vancouver build a city headed for resilience rather than obsolescence?

1. Events, Workshops, Studies

Under the "Built for Change" program, the Commission conducted the following public events, workshops and studies, culminating in the development of the Change Charter encapsulating key principles for an adaptable city:

- Public presentation by Councilor Robert Liberty, Metro Portland, on the Politics and Principles of Urban Sustainability.
- Summit on Change exploring the drivers of change in the city with thought leaders in government, technology, non-profit sector and business.
- Public presentation by Professor Robert Kronenburg from the University of Liverpool on Flexible Architecture that responds to change.
- Youth Challenge workshop where high school school students planned city neighbourhoods for the future.
- Adaptability workshop where community leaders and planners explored strategies for adaptability in neighbourhood centres, single-family neighbourhoods, and gathering places.
- YouMap Vancouver, an innovative neighbourhood mapping project to engage citizens in mapping tangible and intangible community assets and in creative thinking about change.

- Rental Housing Policy review and recommendations to accelerate the production of rental housing.
- Research projects in building for adaptability by planning student interns.
- Change Charter, defining adaptability as the key tenet of sustainability and outlining a set of adaptability principles that should underlie planning and decision-making in the interest of creating a resilient city.
