2. Current Events

The Committee provided updates on current events, and noted that an anti-racism rally is taking place on December 11, 2016, at the Brighouse Canada Line station in Richmond.

Councillor Meggs also responded to questions.

4. Staff Liaison Updates

Commissioner McKinnon provided an update and noted that the Park Board approved the "Access to Park Board Services Without Fear Policy". He also noted the 2017 Operating and Capital Budget was approved, and provided an update regarding the new Joint Operating Agreement between the Park Board and Community Centre Associations, which is to take effect on June 1, 2017, if approved.

Councillor Meggs noted that a motion regarding "Action to Speed Refugee Arrivals" will be on the agenda for the Regular Council meeting on December 13, 2016. Councillor Meggs also

provided an update regarding the settlement experience of Syrian refugees, and also commented on the policing, safety and security of residents regardless of status or residency.

Staff Liaison Rajpal Kohli provided an update on the Trans^{*} Gender Variant and Two-Spirit Inclusion action plan, and noted that staff are currently focusing on Quick Starts.

Quick Starts is noted in Table 1 of the Administrative Report dated June 8, 2016, entitled "Supporting Trans* Equality and an Inclusive Vancouver", and is available at the following link: <u>http://council.vancouver.ca/20160713/documents/cfsc6.pdf</u>

Ms. Kohli also noted that staff will be working with the Women's Advisory Committee to establish a process for reviewing and updating the 2005 Gender Equality Strategy.

5. Subcommittee Updates

Will Tao provided an update on this matter, and thanked Nellie Cheng and Francisco Barajas for their work on the draft Spaces survey. Mr. Tao also noted they are looking into an engagement strategy to draw interest to the survey.

b) Engagement

Kat Cureton provided an update on the engagement strategy document, and noted that she and Thanh Lam are finalizing the recommendations.

6. Next Steps - Working Sessions in January and February

The Committee discussed their upcoming working sessions, and explored ways to establish a list of individuals and organizations interested in completing the Spaces survey. Councillor Meggs suggested that Amanda Mitchell, Public Engagement Specialist be contacted to assist with this process.

The Committee reviewed their accomplishments and, moving forward, shared ideas and offered suggestions for topics, priorities, projects, and format and delivery, for the new Committee.

Suggestions included:

- Establish Working Guidelines and Community Agreements
- Define "Culture" for the purpose of the Culture Communities Advisory Committee
- Develop a social media presence and create a Facebook page
- Continue to support projects such as "Culture: Fourth Pillar of Sustainability"
