

River District Area 1 Street Naming - Recommendations

I would like to thank the Committee for including Parklane Homes in the street naming process and for their thoughtful consideration on this matter. As the Community Builder of River District and a primary stakeholder in the success of this new Vancouver community we believe that the street names are a critical piece of the ongoing success of the commercial/ retail heart of the River District neighbourhood. Our primary objectives for the street names are as follows:

- Street names that utilize a mix of authentic names that distinguish the community, celebrate the past, relate to the natural environment, and showcase the rich history of the mill.
- Themes and preferences towards more generic names that are positively relatable to a diverse range of audiences.
- Names that are immediately comprehensible, relatable, and clear.
- Reflect the high importance of Road 12 and Road 13 in the approval process.

As requested at the May 6, 2013 Civic Asset Naming Committee meeting we have considered the Committee provided names and the clarification on duplicates and double and triple-barreled names provided by Les Mobbs, City Archivist and Emergency Services.


Proposed Names:

ParkLane Homes has reviewed the list of street names based on the abovementioned street naming and emergency response criteria and would like to put forth the following street name recommendations of Roads 7, 12, and 13/23 per the diagram below.

Note: Road 13 was formerly Road 13 and Road 23. As Road 23 is an extension of Road 13, both roads will share one name. The following is a compiled list of street names that comply with the Civic Asset Naming Committee criteria:
