Suggestion to add name to Name Reserve List: Jim Deva

Quoting from email submission:

Jim cofounded the Little Sister's Book and Art Emporium. Jim is best known for the long and successful fight that he and store manager Janine Fuller waged against Canada Customs censors, who tried to prevent LGBT literature from being brought across the border. The bookstore served as a community gathering space for more than three decades. To quote Mayor Robertson, "He was an inspiration to Vancouver and all Canadians, and his irrepressible courage and tireless advocacy for equal rights and free expression played an enormous role in shaping the city that Vancouver is today."

The requestor suggests the name for any asset in the West End.

Staff comments:

At its Regular meeting on October 14, 2014, Vancouver City Council approved a motion entitled "Recognizing Jim Deva's Legacy". The motion states:

WHFRFAS

- 1. The passing of Jim Deva has prompted a remarkable outpouring of community reflection on his life and legacy as a champion for LGBTTQ equality, free expression, and social justice;
- 2. Vancouver City Council is immensely grateful for Jim Deva's outstanding role in shaping the city that Vancouver is today, and a lifetime of leadership and advocacy for human rights that echoed all the way to Supreme Court of Canada;
- 3. The City of Vancouver is committed to building on Jim Deva's legacy by continuing and expanding its leading advocacy for LGBTTQ equality, rights, and inclusion;
- 4. The community-driven West End Plan recently approved by Council recognizes the Davie Village as a 'culturally and historically important hub for Vancouver's LGBTTQ community', identifies Davie and Bute as the heart of Davie Village, and extensive consultation has now been completed on the recommendation of an enhanced, permanent plaza at Davie and Bute.

THEREFORE BE IT RESOLVED

- A. THAT staff be directed to report back on options to identify an appropriate place or civic asset to be named in recognition of Jim Deva and his lifetime of advocacy, working with the input of Jim Deva's family, the City of Vancouver's LGBTQ Advisory Committee, the Park Board, and the Civic Asset Naming Committee.
- B. THAT staff be directed to report back on the results of recent consultation done as part of the West End Community Plan on the future of an enhanced, permanent plaza at Davie and Bute, with a view to exploring this plaza as one potential option for recognition of Jim Deva's life and legacy and the history and contributions of the LGBTTQ community in Vancouver.

As a result of the West End Community Plan's vision for laneway development, the Civic Asset Naming Committee is currently responding to a need to begin recommending names for lanes in the West End. There is a desire to focus these names on individuals with strong connections to the neighbourhood. Should the Bute Street Plaza not be the chosen option for commemorating Mr. Deva's legacy, a lane could be a fitting alternative.

"Jim Deva" does not pose any public safety issues.
