4. Washroom Signage with Guests from Trans* and Gender Variant Inclusion Steering Committee

The Committee along with guests from Trans* and Gender Variant Inclusion Steering Committee at the Park Board discussed best practices for washroom signage. Washroom signage at three Park Board facilities (Hillcrest, Templeton Park and Trout Lake) have been installed. Work is in progress for signage at City Hall, the Vancouver Public Library and Civic Theatres. Samples of signage are on file.

THAT the LGBTQ2+ Advisory Committee recommends that any and all washroom signage updates include the following core elements:

- to remove the male and female icons from all washroom and wayfinding signs and replace with functional icons (e.g. toilet, shower, baby);
- use the full word men, women and universal noting men and women to be used for all multi-stall gender designated washrooms and change rooms and in all other cases universal to be used;
- braille as required by the building code; and
- use of trans people welcome on all signs.
