## 2. Urban Aboriginal Peoples Advisory Committee

Chase Willier welcomed Winona Stevens and Steven Eastman from the Urban Aboriginal Peoples Advisory Committee (UAPAC) to the meeting. Ms. Stevens and Mr. Eastman provided some background on projects the UAPAC has been working on and expressed interest in working with the LGBTQ2+ Advisory Committee in the future and responded to guestions.

### 3. Motion - Truth and Reconciliation Sub-Committee

The Committee reviewed and discussed the motion put forward by the Truth and Reconciliation Sub-Committee.

#### **WHEREAS**

- 1. The LGBTQ2+ Advisory Committee (the "Committee") has indicated in the 2017-2018 workplan, an objective of establishing a working relationship with the Urban Aboriginal Peoples' Advisory Committee ("UAPAC"), one of a closer collaboration and communication. Both committees have indicated objectives of an intersectional nature.
- 2. The Committee has extended an invitation to the UAPAC's co-chairs and/or other committee member to present at the November 23rd, 2017, Committee meeting to provide an update and overview on UAPAC's work this current term.
- 3. The Committee wishes to respectfully request the opportunity to "brainstorm" with UAPAC to develop ideas to further the City of Vancouver's (the "City") reconciliation work and which UAPAC and the Committee could jointly recommend for action to Vancouver City Council (the "Council").
- 4. The Committee has established a Truth and Reconciliation Sub-Committee (the "Sub-Committee") as we share representation specific to the queer, Indigenous and Two-Spirit communities.
- 5. The Committee has learned that the City is considering expanding the scope of its two social planning positions for sex workers to include Indigenous women (including those that identify as LGBTQ2+) and safety (the "Social Planning Expansion").

### THEREFORE BE IT RESOLVED THAT:

- A. The Committee wishes to collaborate with UAPAC in the early part of the calendar year in 2018 in order to meet their shared objectives.
- B. The Committee requests that Council provide City resources and support for UAPAC representatives and the Committee or the Truth and Reconciliation Sub-Committee to hold a joint brainstorming meeting.
- C. The Committee recommends that Council support and fund the Social Planning Expansion.

### 4. Motion - "Conversion Therapy" Sub-Committee

Brooklyn Fowler presented the motion put forward by the "Conversion Therapy" Sub-Committee and responded to questions.

MOVED by Brooklyn Fowler SECONDED by Yogi Omar

### **WHEREAS**

- 1. The City of Vancouver (the "City") is committed to being a safe and welcoming community for LGBTQ2+ individuals, as demonstrated by the adoption and ongoing implementation by the City and the Park Board of a Trans, Gender Variant, and Two Spirit Inclusion Policy and the Vancouver School Board Sexual Orientation and Gender Identities Policy.
- 2. The practice of so-called "Conversion Therapy" (also referred to as "Reparative Therapy") by which pseudoscientific practices are used with intentions of converting an individual's sexuality or gender identity into alignment with the heterosexual and cisgender majority can cause profound and lasting trauma to survivors<sup>1</sup>. As written in the Pan American Health Organization (a branch of the World Health Organization), it is "critical to prevent the application of theories and models that view homosexuality as a 'deviation' or a choice that can be modified through 'will power' or supposed 'therapeutic support'" (Pan American Health Organization-World Health Organization, 2012).
- 3. These practices have been rejected as baseless and damaging by the Canadian Psychological Association, the Canadian Association of Social Workers, the World Health Organization, the American Psychiatric Association, the American Medical Association, the American Psychological Association, the American Academy of Child and Adolescent Psychiatry, the National Association of Social Workers, and the American Counselling Association.
- 4. In its policy statement opposing "Conversion Therapy" practices, the Canadian Psychological Association states: "Scientific research does not support the efficacy of conversion or reparative therapy (Haldeman, 1994; Spitzer, 2012; see Anton, 2010). Conversion or reparative therapy can result in negative outcomes such as distress, anxiety, depression, negative self-image, a feeling of personal failure, difficulty sustaining relationships, and sexual dysfunction (e.g., Haldeman, 2001; Shidlo & Schroeder, 2002; Beckstead & Morrow, 2004; Glassgold et al., 2009)."
- 5. "Conversion Therapy" is an umbrella term meant to include a spectrum of practices not always referred to as "Conversion Therapy". These practises can range from religious rites, behavioural modification or medication, to electroshock therapy or lobotomy. While its practise may take a variety of

forms, the psychological damage, deliberately imposed self-loathing, and other impacts have lasting effects on survivors.

- 6. The Province of Ontario, in 2015, adopted the Affirming Sexual Orientation and Gender Identity Act to protect minors from being subjected to "Conversion Therapy" and to prohibit practitioners from billing "Conversion Therapy" through public health insurance. Furthermore, the province of Manitoba in 2015 has passed a health regulation banning "Conversion Therapy". Nine American states, and twenty-seven American municipalities, counties, and communities including Seattle, Miami, Philadelphia, and Cincinnati have banned the practice.
- 7. The City of Vancouver currently has License By-law No. 4450 that regulates how entities operate in order to "protect public health and safety" and furthermore to "protect vulnerable populations" such as youth, as well as sexual and gender minorities.

THEREFORE BE IT RESOLVED THAT the Committee recommends that Council puts forward amendments to the City By-laws including License By-law No. 4450 to prohibit the provision of "conversion therapy" services and those services that purport to alter an individual's sexual orientation or gender identity by entities licensed by the City of Vancouver.

## 5. Motion - Housing Sub-Committee

Jen Donovan presented the motion put forward by the Housing Sub-Committee and responded to questions.

MOVED by Carolyn Camman SECONDED by Linnea Strom

#### **WHEREAS**

- 1. The City of Vancouver (the "City") is committed to being a safe and welcoming community for LGBTQ2+ individuals. In 2016, Vancouver implemented a five pillar Trans, Gender Variant, Two Spirit (TGV2S) Inclusion Policy that identified a need and made subsequent recommendations for actions to address the increased risk and barriers associated TGV2S populations accessing housing services in Vancouver [TGV2S Inclusion Policy recommendation 2A].
- 2. As part of the City's Housing Reset there are current housing initiatives being implemented by the City, such as the roll-out of temporary modular homes, that parallel the TGV2S Inclusion Policy recommendations of:
  - leveraging City land [TGV2S Inclusion Policy recommendation 2Ai];
  - performing community consultation [TGV2S Inclusion Policy recommendation 5B]; and
  - establishing community/stakeholder partnerships towards implementation [TGV2S Inclusion Policy recommendation 3Ai, 4Cii, and 5Ci].
- 3. The TGV2S Inclusion Policy recommendations have not been implemented into the Housing and Homelessness Strategy 2012-2021 (CoV 2011).
- 4. The TGV2S Inclusion Policy applies to all existing and future programs and services including but not limited to the City's Housing initiatives [TGV2S Inclusion Policy recommendation 2B].

#### THEREFORE BE IT RESOLVED THAT:

A. The Committee recommends that Council directs City staff to include an addendum to the City's Housing Reset Policy and to include policies for

trans people in market housing, City shelters, and other municipally-controlled housing.

B. The Committee recommends that Council directs City staff to prioritize the implementation of the TGV2S Inclusion Policy in the mandates of existing and future housing initiatives.
