# 1. Rize Alliance Development, Kingsway and Broadway (228-246 West Broadway)

Maureen Smith, id ă Public Art Consulting, presented a proposed public art strategy for a mixed use development at 228 - 246 West Broadway, as part of the Rize Alliance Development, and sought the Committee's input.

In discussion, points raised included:

- prefer a site for rotating art work; if not financially feasible, then proceed with a permanent art project;
- consider culminating with a permanent art project;
- plan should include consideration of management of the rotating art project and the costs; and
- determine whether the developers will contribute to the costs of the fit up of the art work space and whether they will maintain ownership of the art work space.

### 2. Bosa Properties, 633 Main Street Development and 221A Art Space

At its meeting held May 5, 2014, the Public Art Committee received an overview of a proposed plan to fulfil the public art requirement for the upcoming Bosa development at 633 Main Street and requested the proponents move forward with developing a Detailed Public Art plan for review at a future meeting.

Accordingly, Barbara Cole, Consultant, Cole Projects, and Brian McBay, Director, 221A, presented a curatorial and business plan for the vacant building lot on Union Street and sought the Committee's input.

*In discussion, points raised included:* 

- staff will work with the proponents on the financial and legal arrangements respecting the City contribution; and
- the Consultants were requested to report back to seek approval.
