1. Rize - Broadway and Kingsway

Maureen Smith, Public Art Consultant, provided a presentation on a development by Rize Alliance Properties ("The Independent") located at the intersection of Kingsway and Broadway and reviewed the public art opportunity. Ms. Smith responded to questions and sought feedback regarding the proposed public art approach.

2. Concord Pacific - 201 West 2nd Avenue

Maureen Smith, Public Art Consultant, provided an introduction to an upcoming development at 201 West 2nd Avenue and reviewed potential public art opportunities. She noted the preference is for the artwork to be sited away from the building given the generous amount of outdoor areas included in the site plan.

3. Washington Properties - 4951 Cambie at West 35th Avenue

Maureen Smith, Public Art Consultant, reviewed the development plans and potential public art opportunities for a project at 4951 Cambie Street and sought Committee feedback. During discussion, Ms. Smith noted the likelihood was for ground-oriented artwork.

Karen Henry provided updates on several civic projects, including information on site planning and upcoming projects including artworks by Dana Claxton at Canada Line City Centre Station, Lead Pencil Studio at Hastings Park and the opening for the new artwork by Luke Marsden in Stanley Park.
