# 1. Correspondence

# 2. 1335 Howe Street, Onni Group

Consultant Jan Ballard, Ballard Fine Art, and Gwyn Vose, IBI Group Architects, provided an introduction to the Onni Group development at 1335 Howe Street, including a review of the related public art opportunity, and responded to questions and feedback from the Committee.

# 3. Lot P, Great Northern Way, Onni Group

Consultant Jan Ballard, Ballard Fine Art, provided an introduction to Lot P development by Onni Group, located on Great Northern Way, and reviewed the two public art opportunities for this development.
