## 1. Review of October 17, 2016, informal meeting

Karen Henry and the Chair provided an overview on matters which were discussed at the informal (no quorum) meeting on October 17, 2016:

- 1380-1382 Hornby St (Grosvenor) preliminary plans were presented and members provided feedback;
- 375 West 59<sup>th</sup> Avenue (Belpark, Intracorp) preliminary plans were presented and members provided feedback;
- 800 Robson City staff presented preliminary plans for closure and sought Committee feedback.

## 2. Northeast False Creek Planning

Holly Sovdi, Planner, Northeast False Creek Project Office, and Emory Davidge, Engagement Specialist, provided an overview of the Northeast False Creek planning process including review of project timelines, public benefit strategy, engagement process, and public input received to date. Mr. Sovdi and Ms. Davidge responded to questions and feedback from the Committee.

## 3. Avenue One, 1768 Cook Street - Concord Pacific

Consultant Maureen Smith provided an overview of the Detailed Public Art Plan for the "Avenue One" project at 1768 Cook Street, which was originally introduced to the Committee on March 9, 2015, and responded to questions from the Committee. She noted there are five proposed sites for the public art opportunity for the selected artist to choose from.

It was noted there are five zones identified for public art, and two planned artworks, including a curated video screen for which artists will be commissioned for set temporary periods.

Ms. Ballard responded to questions and received feedback from the Committee regarding the proposed video screen. This item will be brought back to a future meeting for further consideration.
