1. Civic Project Updates

2. Westbank - 650 West 41st Avenue (Oakridge)

Rui Nunnes, Henriquez Architects, provided an overview of the project's development application history and provided an overview of the updated Westbank development at 640 West 41st (Oakridge).

Reid Shier, Public Art Consultant, introduced the two-stage invitational selection process for the public art opportunity, noting that the larger budget may provide greater opportunity. Mr. Shier noted there is flexibility with the location of the public art with the option to utilize one or multiple locations.

The Committee provided the following feedback:

- Diversify the advisory panel in terms of gender, age, and geographic location
- Incorporate local First Nations in the process
- Include manner in which artist can give back to the community (fabrication of the art piece(s) done locally, community workshops, etc.)
- Ensure panelists are provided robust and relevant information of the local area
