1. Civic Project Updates

Staff provided an update and sought feedback on the following:

- Public Art Plan Budget template;
- research completed on the fee structures for Public Art Consultants; and
- Creative City Strategy Staff Update. A meeting was subsequently confirmed for:
 - Emily Carr Aboriginal Gathering Place, June 25, 2018, 5 to 7 pm.

In discussion, members expressed general support and thanked staff for the enormous effort in completing the research and budget template. Staff will seek input from consultants and bring an adjusted budget template to a future meeting.

2. Westbank – 650 West 41st Avenue (Oakridge)

Reid Shier, Public Art Consultant, along with Gregory Henriquez, presented a Detailed Public Art Plan for the Oakridge development at 41st Avenue and Cambie, and responded to questions.

In discussion, members requested the following information be included in the final Detailed Public Art plan:

- a breakdown of the budget and associated opportunities;
- timeline of opportunities in relation to how this project will be phased;
- panel/s in relation to different opportunities; lists of prospective panelists;
- strategies for mentoring less experienced artists;
- list of artists you would reach out to and methods of reaching national and international artists:
- list of potential mentors, expectations of the work and how this will be organized; and
- more detailed architectural plans.

4. Arts and Culture Policy Council Update

Cathy Busby, Liaison to the Arts and Culture Policy Council, provided a brief update from the ACPC meeting held May 8, 2018.
