## 1. Reconciliation Canada Presentation

Chief Dr. Robert Joseph, Ambassador, and Karen Joseph, Executive Director, both from Reconciliation Canada, provided an overview of reconciliation in British Columbia and some of the initiatives they are currently working on. They noted they are looking for 1200 volunteers leading up to the Reconciliation Walk on September 22, 2013, and people can sign up through the website: <a href="www.reconciliationcanada.ca">www.reconciliationcanada.ca</a>. They also noted they would like Vancouver to be named the City of Reconciliation and have a "Year of Reconciliation".

In discussion, it was noted it would be a good idea to have a follow up session, open to anyone interested from Council, Park Board, School Board or community organizers.

# 4. Standing Senate Committee on Human Rights

The Co-Chairs provided a report on their participation at the Standing Senate Committee on Human Rights. They noted they only had a short time to present and the discussion with Senators kept going back to reserve issues. They also explained that after the meeting in a conversation with Senator Mobina Jaffer, she extended an invitation to them to travel to Ottawa in 2013 to have a one hour session on Urban Aboriginal issues.

# 6. Liaisons & Community Events Updates

## 7. Idle No More

Lillian Howard, Co- Chair, introduced the Idle No More movement. Guests presented their stories and experiences with Idle No More. In discussion, it was noted that bills C45 and C48 virtually strip the abilities of First Nations to negotiate over their land, and that there will be various events including more teach-ins to expand awareness of these bills.

Mona Woodward noted that on Friday, January 25, 2013, the group Butterflies and Spirit will be dancing at Georgia and Granville Streets at noon as part of the Idle No More demonstrations.

THAT the Urban Aboriginal Peoples' Advisory Committee recommend to Council:

- A. THAT the City of Vancouver recognize the United Nations Declaration of Indigenous Right in light of Idle no More and Reconciliation Canada.
- B. THAT Council support teach-ins throughout the City of Vancouver regarding the rights of indigenous peoples to bridge the gaps of First Nations and the rest of Canadians. Teach-ins should include the Canadian Government changes to bills C45 and C38, and any other changes that affect Aboriginal people.
