The Committee finalized plans for volunteering at the National Aboriginal Day celebration taking place at the Vancouver Aboriginal Friendship Centre's West Coast Night on June 15, 2016.

## 2. St. Paul's Hospital

Co-Chair Eastman provided an update on the last meeting with the group doing the Social Impact Analysis for the new St. Paul's Hospital, noting they were able to communicate a large amount of information about what would be appropriate additions and services for the new hospital.

# 5. Liaison Updates

#### a. Parks and Recreation

jil weaving, Vancouver Parks and Recreation, provided an update on the status of the Survivor's Pole, noting that the Park Board is being approached to raise the pole in Pigeon Park.

In discussion, members noted they would like to be more involved with the raising ceremony, gifting and potlatching. Members also discussed sending a letter of encouragement to the artist carving the pole.

#### **WHEREAS**

- 1. The Downtown Eastside is a gathering space for Urban Aboriginal Peoples;
- 2. Although the Downtown Eastside has a history of violence, trauma, racism and injustice, it is also a place of community, celebration, and life;
- 3. The Survivor's Pole is a visible representation of reconciliation and healing
- 4. The Survivor's Pole symbolizes resistance, persistence and inclusion in the Downtown Eastside.

THEREFORE BE IT RESOLVED THAT the Urban Aboriginal Peoples' Advisory Committee support the raising of the Survivor's Pole in Pigeon Park.

- a. Campaign to Designate National Aboriginal Day as a National Statutory Holiday

#### **WHEREAS**

- 1. The City of Vancouver has proclaimed Vancouver to be a City of Reconciliation;
- 2. National Aboriginal Day was established to recognize and celebrate the contributions, experiences, and unique heritage of Aboriginal peoples across Canada.

THEREFORE BE IT RESOLVED THAT the Urban Aboriginal Peoples' Advisory Committee request Council support the establishment of National Aboriginal Day as a national statutory holiday.

FURTHER THAT the Urban Aboriginal Peoples' Advisory Committee request Council take the first steps towards this and give City staff National Aboriginal Day (June 21) as a paid holiday.
