d) Manager's Report

The Commission Manager provided a verbal report which included the following:

- staff presentation confirmed regarding public space planning, with specific focus on downtown and Robson Square;
- the 2013 meeting schedule will be prepared once Council has approved its 2013 meeting schedule;
- a nomination committee meeting is scheduled this week to review applications; and
- Commissioners Matis and Zhu have served three-consecutive terms and will, therefore, not be returning.

2. BUSINESS MEETING

a) Presentation: City of Vancouver Climate Change Adaptation Strategy

David Ramslie, Senior Programs Manager, and Tamsin Mills, Policy Analyst, both from the Sustainability Group, presented a climate change adaptation strategy and responded to questions.

Highlights of the presentation included:

Adaptation:

- review of guiding principles
- anticipated changes and prioritized impacts including:
 - o increased surface water flooding and sewer back-ups;
 - increase in landslide risk;
 - o safety and health risks, in particular, vulnerable population;
 - o increased resources needed for response and recovery; and
 - o flooding, erosion damage.
- summary of primary actions:
 - o sea level rise flood-proofing;
 - o sea level rise coastal flood risk assessment; and
 - o sewer separation (currently underway).

Mitigation:

- review of provincial legislation guiding actions on mitigation;
- goals include the elimination of dependency on fossil fuels;
- review of Greenest City Action Plan; and
- review of successes and challenges.

b) Transportation Plan Committee

The Chair requested the two committees meet jointly immediately following this meeting to discuss their work plans.

Commissioner Marian Brown gave a brief verbal update in relation to discussions on the Fraser Shoreline and greenways.

c) City-wide Plan Committee

Commissioner Catriona Feeney gave a brief verbal update on progress.
