#### 2. BUSINESS MEETING

## a) Presentation: Downtown Public Space Planning incl. Robson Square

Jennifer Sheel, Transportation Engineer, Streets Activities, and Michael Gordon, Senior Planner, Central Area Planning Branch, provided a presentation on Downtown Public Space Planning and responded to questions.

Highlights of the presentation included:

- overview of public space planning in the Downtown;
- strong public interest in public spaces;
- a report regarding a permanent public plaza at 800-block Robson Street will be going to Council on November 28, 2012;
- stakeholder concerns in regard to the proposed closure of the 800-block Robson Street include:
  - #5 Robson Bus re-route:
  - traffic congestion;
  - the need for inclusivity; and
  - impacts of programming choices.

## b) Transportation Plan Committee

Commissioner Marian Brown provided a verbal update on the Committee's discussions on the Fraser Shoreline and greenways/blueways.

## c) City-wide Plan Committee

Commissioner Caitriona Feeney reported that the Committee agreed to continue their readings on the Regional Growth Strategy and maintain their focus on the Regional Context Statement by the City required before July of next year. She also advised that the Committee agreed to discuss the idea of changing the committee's name to 'Citywide Planning Committee' at the Committee's next meeting. She noted that the current name of the committee is somewhat misleading as there is no comprehensive or physical city-wide plan process underway at this time.

## a) Work Plan 2013 Review

The Chair suggested the Commission review the Work Plan for 2012 at the next meeting and update it for 2013. He also noted this will be the first meeting for newly appointed Commissioners; therefore, it would be beneficial for the two Committees to provide updates on their plans for the year.
