The Commission Manager provided her report (on file) noting the following:

- No further developments on the new VCPC office space.

## e) Reports from Liaison Members

Commissioner Loke provided an update on matters related to the OneCard Program and noted that the next Park Board meeting is September 23, 2013.

Trustee Lombardi provided an update on the following matters:

- Impact of decreasing numbers of students on the 2013-2014 budget;
- Implementation of exit surveys and welcome letters to help assess enrollment trends;
- Completion of seismic upgrades at Douglas and Sexsmith Elementary schools and upcoming upgrades at Kitsilano Secondary;
- A motion has been passed to allow a student trustee, elected by the student body, to participate in School Board debates.

Councillor Tang provided an update on the following matters:

- Of the four community plans, Marpole and Grandview-Woodland have been receiving the most media attention over the summer;
- A motion requesting a timeline extension for the Grandview-Woodland Community Plan has been referred to the Standing Committee on City Finance and Services meeting on September 25, 2013;
- Council will be considering a proposal for a mixed use development at Oakridge Centre that will include buildings up to 45 storeys;
- The Hastings Park/PNE Governance Review, Vancouver Public Bike Share and Point Grey Cornwall Transportation Corridor were all approved before Council recessed for the summer;
- The next Regular Council meeting is September 24, 2013.

In response to a question, Councillor Tang requested that the Commission Manager enquire about the possibility of receiving advance notifications of upcoming rezoning applications.
