# e) Reports from Liaison Members

- Two new replacement schools have opened;
- The Board now includes a Student Trustee;
- The five year Capital Plan has been submitted;
- The Board is responsible for funding the pay increase of support staff which was agreed through negotiations of staff and the Provincial Government.

- 2014 Budget Outlook was presented to Council on October 8, 2013;
- The Mount Pleasant Implementation Plan was considered at Council on October 23, 2013;
- The rezoning of 2290 Main Street and the rezoning of 1412-1480 Howe Street, 1429 Granville Street, 710 Pacific Street and 1410 Granville Street, were dealt with at the Public Hearing on October 24 and 29, 2013.
