Trustee Lombardi reported that:

- The VSB sustainability audit is underway, the goal is to become the greenest school district in North America;
- The Ministry of Education has been slow in approving proposed school sites in the downtown core, where there currently is a shortage. International Village Elementary has been the only new site approved and the School Board is now looking at possible short term options;
- The official budget consultation will start Monday, the School Board is facing a \$15,000,000 shortfall.
