- Clarify direction on conditional and discretionary zoning to improve protection for heritage buildings;
- Simplify/streamline rezoning, development permit and Heritage Revitalization Agreement approval processes for heritage retention applications;
- Increase demolition fees for pre-1940 houses:
- Solicit senior government support for rehabilitation tax incentives; and
- Update the Vancouver Heritage Register.

The Chair of the Vancouver Heritage Commission provided an overview of the Heritage Commission's current projects and overall objectives.
