Chair Krangle reported that she attended open houses on the Joyce-Collingwood Station upgrades and the Stanley Park Causeway upgrades. She will be attending another open house on the Commercial Broadway Station upgrades tomorrow.

Commissioner Matas provided a brief update on the Chronology Project, noting that the project group will be meeting with the UBC SALA adjunct professor and department head tomorrow to map out the course.

c) Museum of Vancouver: Vancouver Project

Commissioner Payson reported that she and the Commission Manager met with Greg Dreicer of the Vancouver Museum to further discuss the Vancouver Project. She provided a brief overview of the project's objectives and asked for the Commission's support in moving forward with it.
