2. REPORTS

a) Report on VCPC Grant Request

The Commission Manager and Chair noted the VCPC Operating Grant was approved at the Standing Committee on Planning, Transportation and Environment meeting held earlier today.

b) Manager's Report

The Commission Manager reported the following:

- Due to Commissioner Payson's resignation, there is a vacancy on the Commission, and a request has been made to Council to fill the vacancy;
- A thank you lunch was held for departing Commissioners;
- Commission meeting dates that fall on Council meeting dates will be reviewed and alternatives will be proposed.

c) Reports from Liaison Members

Commissioner Crawford reported the following:

- The 2015 Park Development Operating and Capital Budget was approved, subject to City Council approval;
- The location for Metro Vancouver's Highbury Interceptor Air Management Facility is Musqueam Park;
- Safety improvements will be made to the Stanley Park Causeway;
- Park Naming Committee to be re-established;
- Vancouver Bluewater Task Force to be established to review current recreational policies and suggest improvements.

Trustee Lombardi reported the following:

- Scott Robinson was recently hired as the Superintendent of Schools;
- Janson Ho was recently hired as the Director for the Vancouver Seismic Project Office;
- A long range facilities plan is underway;
- The Provincial government has hired a special advisor to report on the VBE's finances;
- Misleading statements are circulating regarding a financial surplus, however, this is not accurate.

d) Report on Urban Design Panel

e) Reports from Commissioners

Commissioner B. Yan reported that the UBC School of Community and Regional Planning (SCARP) students want to host the Canadian Association of Planning Students and they are looking for endorsers. He agreed to circulate the endorsement document to Commissioners.

Commissioner A. Yan discussed the recently released Vancity report on housing affordability entitled "Downsizing the Canadian Dream: Homeownership Realities for Millennials and Beyond". He agreed to send a link to the report to Commissioners.

The VCPC manager reported that she attended, along with the past VCPC Chair, the UBC School of Community and Regional Planning (SCARP) Symposium. She agreed to circulate notes from the event to all Commissioners.

Commissioner Johal reported that a discussion entitled "Shaping Vancouver - Conversations on the Heritage Action Plan", will take place on April 16, 2015, at 149 West Hastings Street.

3. BUSINESS MEETING

b) Heritage Action Plan Advisory Committee

Commissioner Carter provided an update on his experience as a member of the Committee. The VCPC Manager agreed to follow-up on receiving a presentation from staff on this matter.

It was agreed a working group would be struck to develop a process for discussing and commenting on Urban Design Panel topics.

d) Planning/Development Milestones Chronology

Commissioner Matas provided an update on the chronology project and noted there will be a public launch at the end of the year.

e) Transit Plebiscite

The VCPC Manger agreed to circulate a draft statement on the Transit Plebiscite to Commissioners for comments.

f) Work Plan 2015

The VCPC Manager agreed to circulate possible dates for the Commission orientation.
