### 2. REPORTS

### a) Reports from Liaison Members

Councillor Carr provided some information in regard to a question surrounding the transit plebiscite that arose at the last VCPC meeting.

Commissioner Crawford reported the following:

- Strathcona and Norquay are joining the Healthy Local Food Fieldhouse Residency Program;
- Barclay Manor and Kensington Community Centre will begin collaborative gardens onsite;
- Staff is investigating a plan to increase water filling stations and possibly ban bottled water in Park Board facilities;
- The Park Board will discuss skate parks at Jonathan Rogers and Mt. Pleasant park at their next meeting;
- A zip line at Queen Elizabeth Park will also be discussed at the next Park Board meeting.

Trustee Lombardi reported that the School Board passed a motion asking the Province to honour their commitment to complete seismic upgrades by 2020 and provided a brief update on the current seismic work being done.

# b) Report on Urban Design Panel

Commissioner LaMontagne reviewed the April 8, 2015, Urban Design Panel meeting, and provided a brief overview of the meeting to be held later today, April 22, 2015.

Commissioner LaMontagne noted the Central Waterfront Hub Framework as a possible topic of interest to the Commission. Commissioners agreed to form a committee to consider possible directions and report back.
