- Planning programs are underway for Cambie 3, False Creek Flats, Viaducts and the Joyce-Collingwood Station Precinct Review;
- Policy consultations for Greenest City and 100% Renewable City as well as the Heritage Action Plan will be ongoing throughout the summer;
- A motion will be going forward to make City facilities more trans-inclusive spaces;
- Staff have been directed to report back on the Truth and Reconciliation Commission Report and determine how the City could enact recommendations;
- Doors Open Vancouver will be taking place on October 2 and 3, 2015, and would be a great opportunity for VCPC to have some visibility at one or more of the sites;
- There is the opportunity for a presentation from the Grandview Woodland Citizen Assembly if the Commission is interested in their processes and recommendations.
