Councillor Carr also responded to enquiries regarding the upcoming Grandview-Woodlands plan.

b) Report on Urban Design Panel

Co-Chair LaMontagne provided an update on the Urban Design Panel meeting held June 29, 2016, reviewed the agenda for the upcoming meeting on July 12, 2016, and responded to questions.

Commissioner Krangle reviewed the Metro Vancouver Board response to the George Massey Tunnel replacement, noting they are generally opposed to it, and identified some of the concerns raised by the Board. Councillor Carr, who was present at the Metro Vancouver meeting where this matter was considered, responded to guestions.

Commissioner A. Yan reported on a roundtable on affordable housing, hosted by Prime Minister Trudeau. He noted that the roundtable seemed oriented towards private development and needed more attendees from the non-market, non-profit, and rental housing sectors.

In discussion, it was noted there is a Federal website http://letstalkhousing.ca where people can fill out a survey and find out about activities related to the Federal Government's plan for a National Housing Strategy.
