a) Reports from Liaison Members

b) Report on Urban Design Panel

Co-Chair LaMontagne reviewed the Urban Design Panel meetings held throughout the summer and provided a brief overview of the meeting to be held October 5, 2016.

At this time, the Commission agreed to make note of their concern over the loss of public space in Vancouver.

THAT the Vancouver City Planning Commission draft a letter to the City of Vancouver's Planning Department registering their concern regarding the loss of public space, both publicly and privately owned, in the downtown core.

c) Report on Heritage Action Plan

Commissioner Matas provided an update on the Heritage Action Plan and the upgrades to the heritage register. He also noted that a presentation on this topic could be arranged for a future VCPC meeting.

d) Reports from Commissioners

Commissioner Perl provided an overview of the Transportation 2040 Working Group meeting, noting there were concerns with aspects of the Arbutus Corridor.

THAT the Vancouver City Planning Commission draft a letter to the City of Vancouver's Planning Department expressing concern regarding the crossings within the Arbutus Corridor.

Commissioner Marshall noted that there is currently a waste management survey on Talk Vancouver that all Commissioners should complete.

Commissioner Carey provided an update on Granville Island 2040 and an overview of the Pro Walk/Pro Bike/Pro Place conference held in September.

e) Report from Executive Director

The Executive Director reported the following:

- The new General Manager of Planning, Urban Design and Sustainability has agreed to meet with the Commission at the Standing Committee meeting on November 9, 2016;
- He will follow up with the General Manager of Business Development, Buildings and Licensing who has expressed interest in learning more about VCPC;
- Presentations on the False Creek Flats and False Creek South have been scheduled for upcoming VCPC meetings;
- Commissioners with terms ending this year must re-apply online before October 28, 2016.

An overview of the September 20 and 21, 2016, Council meetings was also provided.
