3. BUSINESS MEETING

a) Governance Committee Update

Commissioner Crossley noted that as Commissioner LaMontagne indicated his resignation would be forthcoming; an email was sent out to Commissioners to gage interest for filling the resulting vacancy on the Urban Design Panel (UDP). Following discussion it was,

MOVED by Commissioner Crossley SECONDED by Commissioner Fergusson

THAT the Vancouver City Planning Commission (VCPC), recommend Leslie Shieh to fill the vacancy as the Urban Design Panel VCPC representative, contingent on the resignation of the current Urban Design Panel VCPC representative, Neil LaMontagne.

CARRIED UNANIMOUSLY

With the anticipated resignation of Commissioner LaMontagne, discussion ensued as to how to best fill the vacancy and ensure it's widely broadcasted in an open and inclusive manner. The Commission deemed it valuable to create an asset map of the Commission's skill sets in order to determine which sectors/applicants would best round out the Commission. It was also noted that terms of some commissioners would be up this year and are eligible for re-appointment.

b) Joint Advisory Committee Meeting on Housing Issues, August 10, 2017

Commissioner Seymour noted that as most committees have a housing subcommittee, and there is appetite to coordinate efforts; a joint housing meeting is being co-hosted by Commissioner Seymour/VCPC and the Renters Advisory Committee. Commissioners Seymour, Abbot, and Matas will attend the meeting; Commissioner Seymour will extend the invite to Commissioners not present at this meeting.

c) Update on Fall Summit planning and preparations

Commissioner Seymour provided an update on the progress of the Fall Summit, noting that they've been in contact with SFU Public Square; Katie McPherson, Chief Resilience Officer; and a keynote speaker. Potential dates, locations, titles, invitees, and structure of the meeting were also discussed.

4. COMMISSIONER REPORTS

a) Report on Urban Design Panel

b) Reports from Commissioners

Commissioner Huang summarized her trip to Toronto and noted similarities in areas of frustration experienced here.

Commissioner Fergusson attended The Drum is Calling Festival and was both impressed and moved by the community's celebration of its indigenous roots and noted good examples of public space use.

Commissioner Matas was following the Community Amenity Contribution (CAC) Report that went to Council in July, and felt the City should be pursuing areas of CAC's in connection to assessing the cost of development, where the funds actually go, and how the contributions reflect on future planning.

Commissioner Krangle informed the Commission that the Canadian Institute of Planners (CIP) would be celebrating its 100 year anniversary in 2019, and to commemorate the milestone, CIP plans to create a document relating to the history of planning in Vancouver; Commissioner Krangle felt there may be a role for VCPC to participate in that.

The Executive Director's report which was circulated earlier in the day (copy on file), included the following:
