Ingrid Hwang, City-wide and Regional Planning, provided an update (on behalf of Chris Robertson, Staff Liaison), on items from Planning, Urban Development and Sustainability, noting the following:

- Vancouver Regional Context Statement and Regional Growth Strategy
- Regulatory review
- Sustainability and Sea level rise
- Heritage Action Plan, Heritage Density Bank and Heritage Program review

3. BUSINESS MEETING

a) Update on Fall Shaping Resilience Summit

Commissioner Seymoar provided an update on the fall Shaping Resilience Summit noting that the website is up and invites have gone out. Commission agreed to prepare backgrounder summaries on the following: Engagement for real, Inclusion, Financing, and Communities and Corridors.

b) Update on Chronology Committee and Year in Review Planning

Commissioner Matas provided an update on the Chronology Subcommittee and Year in Review planning, noting that they reached out to the Urban Aboriginal Peoples Advisory Committee for feedback.

It was decided to focus on the upcoming events and discuss Terms of Reference for a potential subcommittee at a future date.

c) Council of Councils: Advisory Committee Poster

The Executive Director discussed the upcoming Council of Councils on October 12, 2017, meeting and sought feedback from the group regarding content for the posters and presentation, noting that this is separate and less formal from the yearly report to Council.

4. DTES, HISTORIC AREAS, AND CHINATOWN

Commissioner Crossley provided an update from the Commission's last Standing Committee and debriefed the Commission on Planning's approach to the DTES, historic areas, and Chinatown, noting that he felt issues identified by the City, aligned with issues the Commission had raised; commissioners were encouraged to read through the presentation (copy on file). Councillor Reimer noted that a more articulated set of values in relation to development could help support the current community as well as the broad spectrum of people it supports.

Railtown and Gastown were also discussed at the meeting, and commissioners in attendance found it to be a helpful overview.

5. COMMISSIONER REPORTS AND DISCUSSION

a) Report on Urban Design Panel

Commissioner Shieh provided an update on the September 20' 2017, Urban Design Panel, noting the following projects:

b) Reports from Commissioners

Commissioner Fergusson commented on the following:

- The Transportation 2040 stakeholder advisory group has undergone a slight restructuring and has helped to make the experience more rewarding.
- Cambie Corridor Phase 3 workshop hosted a number of different advisory committees who were able to see some of the design and density plans in advance.

Commissioner Shieh attended a bike tour with Strathcona Business Improvement Association (BIA) and discussed how development of surrounding areas (e.g. False Creek Flats and Gastown) will impact Strathcona's transit systems (for both people and goods).

The Chair noted that perhaps BIAs should be included in more VCPC conversations.

c) Executive Director's Report

The Executive Director summarized his Report (copy on file), noting that the Commission will be hosting another roundtable, with the topic of parking.

The Executive Director noted that online applications for vacant commission spots will be available online on Monday; commissioners encouraged to spread the word to their contacts.
