Councillor Adriane Carr, Council Liaison, provided a brief overview of the October and November Council meetings, as well as upcoming Council meetings, and responded to questions and comments from the Commission.

#### 3. BUSINESS MEETING

# a) Report on Shaping Resiliency Summit

Commissioner Seymoar provided an overview of the Summit, noting that it was an overall success with a good number of participants and noted that surveys returned are being reviewed. Positive feedback about the event was received, and noted that suggestions and learnings from this year will be incorporated into next year's Summit.

# b) Report on Parking Issues Roundtable

Commissioner Krangle summarized the roundtable, noting there were about a dozen people present for the very informative presentation from Jennifer Draper, Manager, Parking Management Branch.

Commission Krangle noted there is enthusiasm for the topic and suggested the Commission consider hosting a follow-up event and/or a small public forum.

# c) Report on 2017 Chronology Milestones Brainstorming Workshop

Commissioner Matas summarized the Chronology workshop, noting additional events were brought forward for consideration; the shortlist of significant events will be the basis for a survey to be sent out in the New Year. A draft survey will be circulated to VCPC for review.

Commissioner Shieh commented positive feedback was received from other civic agency members who were appreciative of VCPC taking initiative in bringing civic agencies together.

### d) Follow-up on MLBE Presentation

Commissioner Crossley summarized the MLBE presentation, noting that he found the presentation very helpful in providing a broad planning overview of the project.

THAT the Vancouver City Planning Commission approve in principle, for a letter be sent to Mayor and Council regarding the Millennium Line Broadway Extension, to be finalized at the Commission's next Standing Committee.

#### e) Proposal for 2018 VCPC Structure and Process

Commissioner Seymoar summarized the Executive Committee's discussion on organizing the Commission's calendar for next year, including the time frame for the 2018 summit and chronology workshop. Advanced planning will be beneficial for next year's events and would create a better opportunity to connect with other committees (e.g. Urban Aboriginal Peoples' Advisory Committee, Cultural Communities Advisory Committee), and consider hiring an event coordinator to help organize the events.

Moved by Commissioner Crossley Seconded by Commissioner Marshall

THAT the Vancouver City Planning Commission agrees in principle, to host a 2018 Summit with a theme of "City for All", and "Resiliency" as the broader theme.

CARRIED UNANIMOUSLY

Commissioner Crossley noted that the Commissions governance structure is being reevaluated and will bring back to the Commission at the December Standing Committee.

At this point in the meeting, the Commission moved to in camera.

MOVED by Commissioner Seymoar SECONDED by Commissioner Crossley

THAT the Vancouver City Planning Commission will go into a meeting later this day which is closed to the public, pursuant to Section 165.2(1) of the Vancouver Charter, to discuss matters related to paragraph:

(a) personal information about an identifiable individual who holds or is being considered for a position as an officer, employee or agent of the city or another position appointed by the city.

FURTHER THAT the Commission accept Commissioner Perl's proposal to align some of his teaching in the Summer and Fall terms of 2018 to enable Simon Fraser University students to engage with, contribute to, and participate in, the 2018 Summit that VCPC will undertake.
