### 3. BUSINESS MEETING

### a) Milestones 2017 Memorandum

Commissioner Matas provided an overview of the draft Milestones memo (copy on file), following discussion, it was:

# b) 2018 Work Plan Update

Commissioner Seymoar encouraged Commissioners to respond to questions circulated; noting that the work plan will be revisited at the next standing committee meeting.

Commissioner Seymoar noted that a brief report on the outcomes and results of joint events between advisory bodies (e.g. housing and parking roundtables hosted by VCPC), would be helpful to send to Mayor and Council to highlight the usefulness of advisory bodies after the municipal election.

Commissioner Krangle to connect with Commissioner Seymoar to amalgamate notes/summaries available; Commissioner Simon expressed an interest to assist.

## c) 2018 Summit Update

Commissioner Fergusson summarized the draft 2018 Summit Plan that was circulated and briefly described the locations for option A and B. The Commission was reminded that the evening event will be open to the public, whereas the daytime workshop will be by invite, and don't necessarily need to be consecutive. It was noted that the day-long event will need to take place on November 26, in order for Commissioner Perl and his students to assist.

Commissioner Crossley agreed to assist with budgeting of the summit; Commissioner Seymoar and the Executive Director agreed to assist with aspects of project management of the summit, and Commissioner Fergusson will continue to create content and requested feedback from the Commission on overarching themes and goals.

### d) VanPlay Deep Dive Feedback

Commissioner Bylicki provided a summary of the draft memo (copy on file). Following discussion, it was:

### b) Report on Transportation 2040 Stakeholder Advisory Group

Commissioner Fergusson provided a brief overview of the 2040 Stakeholder group and encouraged new Commissioners to volunteer as alternates; Commissioner Simon expressed interest and will touch base with Commissioner Fergusson.

### c) Reports from Committees

Commissioner Crossley provided an update on the Governance subcommittee, noting that the policy document will be brought forward at the next meeting.

Commissioner Matas provided a brief update on the Chronology subcommittee noting that SFU expressed interest in including a course on Chronology. In addition, the Vancouver Public Library expressed interest in partnering with the subcommittee in the form of a kiosk at the Library or public program. Commissioner Matas encouraged new commissioners to participate if interested.

Commissioner Matas noted that the Urban Indigenous Peoples Advisory Committee also expressed interest in participating on the subcommittee to when looking at the history of Indigenous lands. Commissioner Seymoar suggested this could be looked at through the Commission's theme of "A City for All", in terms of how groups were excluded

### d) Reports from Commissioners

Commissioner Matas provided an overview on the following:

- SFU's "A Brave New Work" series and shared insights from the lectures.
- Upcoming studies: Employment Lands and Economy, and CityCore 2050, from the City's General Manager of Planning, Urban Design and Sustainability, Gil Kelley

Commissioner Fergusson noted that a land cost/land ownership pro forma prepared for the Urbanarium's Missing Middle competition found that the previous year's pro forma was already out dated as nothing was now considered affordable, and noted that the transfer from private ownership to common ownership (e.g. Community Land Trusts), will become increasingly important to maintain affordability in the city.
