c) Green College (UBC) Visiting Lectureship proposal

THAT the Vancouver City Planning Commission confirm their agreement in principle to partner with Green College at the University of British Columbia to develop a pilot "Vancouver City Planning Commission and Green College Visiting Lectureship" to be cohosted in either November 2018 or March 2019.

FURTHER THAT Commissioners Matas, Marshall, and Fujii, be appointed as Vancouver City Planning Commission liaisons to Green College in the development of this initiative.
