1. ADMINISTRATION

a) Attendance

b) Approval of Minutes

c) Notice of Upcoming VCPC Meetings

Commissioner Seymour advised that the next two regular meetings of the Vancouver City Planning Commission will take place on June 13, and July 18, 2018, and that Standing Committee meetings will take place on May 23 and June 27, 2018.

2. LIAISON MEMBER REPORTS

a) Reports from Liaison Members

Commissioner Evans, Park Board Liaison, provided brief updates on the following:

- Oakridge Park development open houses will take place on May 9, 2018, from 4 pm to 7 pm and on Saturday, May 12, 2018, from 11 am to 2 pm.
- China Creek will be receiving upgrades to provide a more accessible path from the hill down to the playground.
- Memorial Park South will be getting age-friendly outdoor fitness equipment.
- A staff report regarding Langara Golf Course will be presented to Park Board in June, meanwhile there is a proposal to move forward on partial drainage.

Michelle McGuire, Planning, Urban Design, and Sustainability, provided brief updates on the following:

- Oakridge open houses this week will also deal with the preliminary development application.
- The False Creek South provisional vision statement and the Heather Lands Policy Statement will be presented to Council on Tuesday, May 15, 2018.
- The Utility Servicing Strategy for the Cambie Corridor will be presented to Council later this year before the August break.
- Terms of Reference for an overall land use planning in the Broadway Corridor will go to Council in June.

Ms. McGuire also responded to questions.

3. BUSINESS MEETING

a) WUF9-A City for All Workshop Recap

Commissioner Bylicki reviewed the City for All Workshop (*notes distributed – on file*), noting much of the focus was on citizen and community-wide engagement. She agreed to consolidate and send out notes to participants.

b) 2018 Summit Update

Commissioner Seymoar noted that the original date for the 2018 Summit conflicts with the International Day of Persons with Disabilities, however either December 4 or 5 could be used an alternate date.

Commissioner Perl noted that, if the Commission wants students from the SFU Urban Studies program to assist, waiting until September would be appropriate so that the new students have their availability.

In discussion, the Commission agreed to postpone decision on a date until September, and having Summit planning meeting on May 30, 2018. Commissioner Seymoar requested Commissioners think about possible themes for the Summit prior to the meeting on May 30, 2018.

c) Future of Langara Golf Course Correspondence

The Executive Director reviewed the proposed memo for Council and Park Board regarding the future of the Langara Golf Course (*distributed – on file*).

Commissioner Matas provided an update on the Metro Vancouver Regional Planning Committee, and two studies related to health and community design. As well, Commissioner Matas and Commissioner Bylicki provided an review of the "Rethinking the Region VI: Municipal Responsibility in an Age of Urban Inequality" conference that took place on April 28, 2018.
