### 1. Welcome and Introductions

Rob Haynes, Chair, welcomed and introduced Fred Withers, Chair, and Kelly Tweeddale, President, Vancouver Symphony Orchestra, followed by roundtable introductions of Board members and staff.

### 2. Vancouver Symphony Orchestra (VSO) Update

Fred Withers, Chair, along with Kelly Tweeddale, President, Vancouver Symphony Orchestra, provided an update on both the Vancouver Symphony Orchestra and the School of Music. Highlights of Mr. Withers' and Ms. Tweeddale's update included:

- Annual Operating Budget;
- Staffing
- Over 1600 students of all ages taking lessons at the school
- Revenue
- 2018-2019 season is the 100<sup>th</sup> birthday of VSO
- Challenges
- VSO 2014-2019 Strategic Plan
- Renting vs Granting.

Mr. Withers and Ms. Tweeddale, along with Sandra Gajic, Director - Civic Theatres, responded to guestions.

Mr. Haynes thanked Mr. Withers and Ms. Tweeddale for their presentation.

Rob Haynes, Chair, received agreement from Board members to invite resident companies to future meetings, as was done previously.

Mr. Haynes provided the following comments:

- Along with Susan Adams and Sabrina Cordeiro, Mr. Haynes attended the International Women's Day event on March 9, 2016, and noted six women were honoured.
- Met with Councillor Heather Deal, and provided her with clarification of the Vancouver Civic Theatres Board, including make-up of the Board, its role which is currently advisory but leaning towards governance, different from other advisory boards as the VCTB monitors/oversees revenue, supportive sounding board for the Director; state of the civic theatres; branding. Councillor Deal commented on the animation of the Plaza and liquor service.

During discussion on ticketing systems, Mr. Haynes, for the benefit of new Board members, provided background on the Ticket Leader proposal.

# 4. Report: Arts and Culture Policy Council

Wendy Soobis, VCTB's representative on the Arts and Culture Policy Council (ACPC), reported on the Arts and Culture Policy Council meeting held on March 22, 2016:

- Sub-Committee updates, including the series of roundtables to be held regarding False Creek Flats;
- Public art presentation large sites that may become tourist attractions;
- Presentation on cultural grants
- Presentation from Artscape, a not-for-profit urban development organization that builds and facilitates new creative spaces.
