### 4. Arts and Culture Policy Council Report

Wendy Soobis, VCT's representative on the Arts and Culture Policy Council (ACPC), provided an update on ACPC initiative's as follows:

ACPC is committed to affecting change in Vancouver's arts and culture and has
developed a motion proposing that culture be considered as the City's fourth pillar of
sustainability. This will be presented at the next Vancouver City Council meeting
on December 13, 2016.

ACPC will recommend to Vancouver City Council that an increase be awarded to the Operating Grants Program under the Cultural Services Department within the 2017 Budget at the December 13<sup>th</sup> council meeting.

# 5. Finance Update

Guy Leroux, Associate Director, Vancouver Civic Theatres, commented that October financials are on target for year to date with net profit of \$750,000 with \$960,000 to capital reserves. November financials not complete yet but expectation of \$1,000,000 to capital reserves plus a little more to bottom line for November year to date.

Mr. Leroux identified some budget items that were incorrectly allocated to the VCT cost centres and is working to have them reversed and responded to guestions.

## 6. Directors Report

Sandra Gajic, Director - Civic Theatres referred to her report, highlighting managements work plan for 2017/2018 and ongoing team development and job fair in January. Ms. Gajic responded to questions and addressed concerns.

Christopher Ball commented to Sandra Gajic about poor sound quality at recent shows at the Queen Elizabeth Theatre. Ms. Gajic responded that staff in process of ordering new sound board to replace aging one at the QET but that clients control what equipment is added to QET stock and the technical crew is managed by the clients.

### 7. New Business

Rob Haynes and Sue Adams recommended a brief overview of VCTB governance at the January 2017 meeting.
