2. Motions for Approval

(a) Presentation from Vancouver School Board of Education (VBE)

THAT the Vancouver Heritage Commission thanks the Vancouver School Board (VSB) for coming to the meeting of October 22, 2012, to provide a summary of the heritage work undertaken and as part of their mandate of seismic upgrading of Vancouver schools, and stresses the importance of the VSB continuing to keep the Commission informed, especially in the early planning process, of future projects which impact heritage buildings.

(b) 2806 - 2850 Cambie Street and 454 West 12th Avenue

FURTHER THAT the Commission requests design work for the underground entrance to the site under the heritage house be more respectful of its single family character. The Commission also requests that the new large building along Cambie Street be more respectful of the historic City Hall by incorporating more vertical elements into the overall massing.

(c) Burrard Bridge

THAT the Vancouver Heritage Commission supports the overall approach of the Burrard Bridge Rehabilitation as noted in the Technical Memorandum dated October 2012.

The Commission requests that the final design for elements that are more intrusive to the overall heritage character including the suicide deterrent barriers, the Pier 1 elevator, the north end widening and the functional lighting (to a lesser degree), and asks that the final design be brought back for comment to the Vancouver Heritage Commission.

Friend House as presented at the November 19, 2012, meeting and drawing to the attention of the proponents of the excessive raising of the heritage house and requests that it be reduced to one foot maximum and requests that the mass of the infill house be proportionally reduced to compliment the lowering of the heritage house and asks that the proponent reduce the number of windows on the front elevation of the infill house and also create a hierarchy of size differential of the upper story windows on the same elevation of the infill house .

The VHC recommends that the heritage house be reroofed with shingles that match the historic wood shingles already on the house and if that is not achievable the VHC recommends installation of a high quality asphalt shingle that respects the character of the heritage house.
