# 1. Gender Equality Strategy Update

Staff from the Equal Employment Opportunity Program and Organizational Development and Strategic Initiatives presented a progress update on the Gender Equality Strategy (GES). It was noted the report is scheduled to go to Council on November 29, 2017, and its overarching theme is "Healthy City Strategy".

The update also included a review of the meetings held with the subcommittees on Leadership/ Representation, Safety/ Violence Against Women, Intersectionality, Childcare and Housing. In addition, the Committee participated in a brainstorm session on potential names for the GES, which staff will be forwarding to the Marketing and Communications team for consideration.

### 2. Subcommittee Updates

The Committee discussed current subcommittees in place and will be focusing on the following areas:

- Leadership and Representation
- Ending Violence Against Women and Girls (EVAWG)
- Outreach, Equity and Inclusion
- Economic Equality and Opportunity for Women and Girls
- Gender Mainstreaming
- Young Women Subcommittee

The Chair noted she will be sending out a listing of each of the subcommittee names and membership to the group.

### 3. Liaison Updates

Councillor Reimer provided an update on the City's Walk for Reconciliation event that took place on September 24, and commented on an amazing experience. She acknowledged the City's commitment to reconciliation has thus far been very transformative. Councillor Reimer also reviewed items that were recently approved by Council and items going forward to Council in the coming months.

Commissioner Evans provided an update on the Park Board's Water Conservation Strategy and noted a huge difference in water savings due to a float valve installed to control potable water additions at Trout Lake. Commissioner Evans also noted the deadline given by the Park Board to Community Centre Associations to sign their Joint Operating Agreements is September 30, 2017. She also mentioned she will be introducing a motion to direct staff to work with Stanley Park's Intergovernmental Working Group to develop a process for re-naming the term "Siwash Rock", which is considered offensive and derogatory.

## 4. Updates from the Chair

The Chair provided a brief update on a recent meeting with the Indonesian Federal Minister for Women Empowerment and Children Protection in British Columbia. The Chair also mentioned the Council of Councils meeting will be taking place on October 12. It was noted there are several requests from various City departments and external organizations to present to WAC. The Committee will be preparing questions to the presenters at an upcoming meeting.

In addition, Paola Quiros reminded members to send their biographies and photos to her by the end of the month.

### 5. Letter to TransLink

The Committee approved a letter to the TransLink Board regarding the Millennium Line Expansion.
