If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (04-1000-20-2016-017); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
