Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of February 11, 2016 for:

Research and analysis records that were used to create the Southwest Marine Drive Rehabilitation Project (Granville Street to Camosun Street) - Bikeway Improvements Report presented on December 10, 2015 at the Standing Committee on Planning, Transportation and Environment.

All responsive records are attached. The collision data was stripped down to only include location, which matches the level of detail of the data available on ICBC's "crash map" website (<http://www.icbc.com/about-icbc/newsroom/Pages/Cyclists.aspx>). ICBC has a non-disclosure agreement with the City, and therefore, the City is unable to disclose raw data provided by ICBC.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request.
