Regarding the vancouver.ca form "Report fraud and misconduct by City staff," a copy of all reports about misuse of public funds, conflict of interest, abuse of position, manipulation or falsification or data, harm to people or property, and any other categories not mentioned above. Please also include the incident reports that indicate the process by which the complaints were investigated and the outcome of the investigation (including recommended action) and whether any complaints were referred to outside agencies.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2016-361); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
