Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

All records of the examinations and findings of the Structural Review Program, including but not restricted to:

- 1. How many buildings and/or building designs were examined;
- 2. Results, actions and any other follow-up;
- 3. Any reports or data collected;
- 4. Any communications, including but not restricted to e-mails, on the structural review program from its start in January 1, 1996 to October 27, 2016.

All responsive records are attached.

Please note: Enclosed spreadsheets identify projects that have (or have not) been reviewed under the "Structural Review Program" which was in place before APEGBC rolled out their specialty designation of Designated Structural Engineers. Enclosed documents contain projects that were forwarded for structural practice review with respect to the type of project and structural engineer of record. There is no additional documentation because this information was used as a registry of projects that were routed to the Chief Building Official's office for their practice review selection. If you would like to proceed with searching any of the files in the spreadsheets, please submit a new FOI request. Since most of these files are likely located in an off-site records storage facility, you will be charged for any retrieval costs.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request. The Act allows you 30 business days from the date you receive this notice to request a review by writing to: Office of the Information & Privacy Commissioner, <u>info@oipc.bc.ca</u> or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-390); 2) a copy of this letter; 3) a copy of

your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
