Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of January 25, 2017 for:

Statistics on reported accidents that occurred between January 1, 2009 and October 22, 2014 where the injured was 12 years of age or younger and the injury occurred either in 1) City of Vancouver fitness centre or 2) City of Vancouver ice rink.

The City has contacted the Board of Parks and Recreation who have confirmed that there is no ability to conduct a thorough search as the records from each of the facilities are not digitized or centralized to date. As a result, gathering and scanning the data from the accident reports from each of the fitness centres (not run by a Community Centre Association) will result in a fee of \$30 per hour.

On February 15, 2017 your request was then clarified to:

Copies of all documents where the form is labelled "ACCIDENT REPORT," where the "date of accident" on said "ACCIDENT REPORT" is between October 22, 2012 and October 22, 2014 and that occurred in either 1) City of Vancouver fitness centre or 2) City of Vancouver ice rink.

As I understand, you are specifically seeking copies of the actual accident reports rather than statistics (as per your original request); however, we are unable to release this kind of record under s.22(1), disclosure harmful to personal privacy. What we have located are reported accident statistics for rinks which I am providing below:

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2017-032); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
