Subject: Chester to stay at VA

John, Malcolm and Margot,

It is now official. Today Fisheries and Oceans Canada (DFO) announced they deem Chester to be non-releasable and has invited us to continue his long-term care at the Vancouver Aquarium.

Last July 10, 2014, a pseudorca (false killer whale) calf was found stranded at Chesterman beach in Tofino, BC. Pseudorcas are rare in British Columbia, typically inhabiting warmer waters. Once it was determined that the pseudorca (later named Chester) would not survive without medical intervention, DFO approved the transfer of Chester to the Aquarium's Marine Mammal Rescue Centre – the only one of its kind in Canada.

We have been fortunate to assemble a world class team led by Dr. Martin Haulena capable of responding to these very rare and intense situations. Our Marine Mammal Rescue Centre has the only professionally trained team in Canada able to rescue this calf and it is something we are all very proud of and is a fundamental part of our mission.

A lot of people helped with his care including the marine mammal rescue team, marine mammal staff, veterinary care staff and of course our amazing volunteers. For many they put their personal lives on hold to ensure that Chester received round the clock feeding, medical care and physiotherapy. After a few months that expert care and dedication had paid off as he was strong, eating well and testing the flexibility of our above ground fiberglass pool with repetitive jumping. He was quickly outgrowing the facility and with much colder weather coming we needed to get him to facilities with better water temperature control.

In December we received a license from DFO to transfer Chester from our Marine Mammal Rescue Centre to the Aquarium. Temporary care was granted in our research pool behind the scenes until a decision could be made regarding a suitable location for his long-term care. DFO planned for the decision to be informed by advice from an expert scientific panel of marine mammal experts from Canada and the United States. The panel quickly determined that Chester would not survive if released into the wild. This assessment was based on the animal's age at stranding, his lack of social contact and foraging skills in the wild, and his extensive contact with humans.

Once deemed non-releasable the search then began for a suitable home. We understand that DFO considered facilities worldwide as possible long-term homes. Currently there are no pseudorca being housed in any facility in North America – there are animals in Japan and China and an older animal in Hawaii. During the facility review DFO asked if we had the capacity to care for Chester here in Vancouver. We confirmed that we had the capacity and were prepared to make that commitment if requested. We had already determined that regardless of the final decision by DFO the next step in Chester's rehabilitation was to recommend relocating him to a larger habitat and to socialize him with other animals; as much fun as he is having with the marine mammal care staff and the close relationship that they have developed they simply cannot replicate the 24-hour presence and complex interactions of a conspecific. For a number of reasons but primarily because of his speed, size, behaviour and environmental requirements the dolphins were considered a very good option. Pacific white sided dolphins have been commonly and successfully housed with false killer whales at other facilities.

There was, of course, a hope that when a decision was made, Chester's introduction would involve both

dolphins; however, no-one could have foreseen the tragic events that unfolded this past week. Despite the loss of Hana the decision was made to keep with the planned announcement as it is in Chester's best interest that we socialize him with others now that he is ready.

This introduction and socialization plan now becomes more important of course as we are looking at the social needs of both Chester and Helen. This will likely be a slow steady process and the expectation, given past histories, is that we should see success. If for some reason this does not unfold then we will be faced with finding other solutions and we are evaluating contingencies for both Chester and Helen.

Over the next week or so you can expect to see modifications being made to the Wild Coast habitat as safety precautions for Chester – much like trying to toddler proof your home – he is an experiential learner and a rambunctious youngster with bags of energy as he explores new things. I expect that it will be a week or two before we are ready to transfer Chester to the Wild Coast and then there will be a period of acclimation before the first introductions are made.

All,

DFO will proceed with an announcement tomorrow regarding the decision that Chester will remain at the Vancouver Aquarium.

If you will recall, in January 2015, Fisheries and Oceans Canada established an external scientific panel to evaluate and help make an informed decision about Chester, the false killer whale (*Pseudorca crassidens*), and his long-term care. The result of that review is that Chester will stay here at the Vancouver Aquarium.

The decision was made prior to the death of Hanna. The habitat must be prepared for Chester which includes some work around its perimeter. This work will raise questions from visitors and staff need to be briefed on why the work is taking place. At this point, very few in the organization are aware of this decision. We need to be able to communicate it out and in order to do that DFO needs to make its announcement.

TALKING POINTS: FALSE KILLER WHALE (May 25, 2015)

Decision on Chester's Long-term Care

- In January 2015, Fisheries and Oceans Canada established an external scientific panel to evaluate and help make an informed decision about Chester, the false killer whale (*Pseudorca crassidens*), and his long-term care. The scientific panel has deemed him non-releasable and in need of long-term care due to his:
 - Age (stranded as a calf still wholly dependent upon its mother to survive)
 - Extensive interaction with humans that have been providing him with treatment and care
 - Inability to forage and survive on his own in the wild
- Options for Chester's long-term care were limited as there are very few false killer whales in human care and Chester was the first false killer whale to be rescued in Canada.
- Fisheries and Oceans Canada has determined that it is in Chester's best interest to continue his long-term care at Canada's leading marine science centre where he will have access to professional veterinary care at an accredited facility with the ability to socialize him with other marine animals in a monitored environment.
- Vancouver Aquarium Marine Science Centre has agreed to continue providing long-term care to Chester, which will include relocating him to a larger habitat that will be better suited to his environmental requirements. Once he is acclimated to his new habitat, the next step in his care will include socialization with other marine mammals, which will begin with an introduction to Pacific white-sided dolphin Helen.
- Head veterinarian Dr. Martin Haulena will continue to oversee his care as he acclimates to his new habitat.
- Vancouver Aquarium will be regularly reporting on Chester's long-term recovery and care to Fisheries and Oceans Canada.

Chester's History

- Chester, the false killer whale, was rescued by the Vancouver Aquarium's Marine Mammal Rescue Centre on July 10, 2014 on North Chesterman Beach where he was found stranded and in distress. At an estimated four to six weeks old, Chester was just a calf when he stranded and has been receiving around-the-clock care and rehabilitation by the Vancouver Aquarium's Marine Mammal Rescue Centre team.
- For nearly 10 months, Chester has received intensive veterinary care as part of his rehabilitation program at the Vancouver Aquarium. Since he stranded as a young calf, still wholly dependent on his mother, Chester will never learn how to forage or protect himself against predators and other dangers, such as boats – skills needed to survive on his own in the wild.

- Cetaceans that strand at a young age are dependent on their mothers; hence, they would not be suitable candidates for release even after a full rehabilitation due to their inability to survive on their own.
 - Chester does not have the skills to forage on his own or protect himself from predators and other possible dangers, such as boats.
 - His lack of life skills puts him at a disadvantage in the wild.
- The Vancouver Aquarium Marine Mammal Rescue Centre was the only professionally trained team able to rescue Chester when he stranded last July. The alternative would have been euthanasia.
 - Chester's remarkable rehabilitation has been an immense learning opportunity for veterinarians, scientists and students around the world as limited literature is available about false killer whales, particularly in Canada.
 - Chester is contributing to a greater body of knowledge by participating in valuable research such as an echolocation research project led by Vancouver Aquarium research associate Kathy Heise.
- Under the guidance of Dr. Haulena, with approval from DFO, the false killer whale will be relocated to Vancouver Aquarium's Wild Coast habitat in the coming weeks.
 - Chester is active, growing and requires a larger habitat for his continued care.
 - Still an adolescent false killer whale, Chester's relocation will require monitoring – the Aquarium provides access to resources to best manage his care.

Vancouver Aquarium Marine Mammal Rescue Centre

- Vancouver Aquarium leads the only marine mammal rescue centre in Canada and is the only real hope for stranded, sick and injured marine mammals in B.C. Only by working with whales and dolphins in human care has the Aquarium been able to refine the professional skills needed to rescue marine mammals like B.C.'s endangered and threatened killer whales.
- Vancouver Aquarium Marine Mammal Rescue Centre rescues, rehabilitates and releases about 100-150 marine mammals a year.
- Of about 100-150 marine mammals rescued a year, sometimes one or two are deemed non-releasable due to their inability to survive on their own. Vancouver Aquarium's Marine Mammal Rescue Centre finds those animals a long-term, caring home at professionally accredited facilities. The alternative is euthanasia.

Vancouver Aquarium Marine Science Centre

- In 1996, Vancouver Aquarium became the first aquarium in the world to make a commitment to no longer capture cetaceans from the wild for display. We now only accept and care for whales, dolphins and porpoises that were born in an aquarium or were rescued and deemed non-releasable by an appropriate government authority.
- Vancouver Aquarium is Canada's leading marine science centre recognized worldwide for its high standards of animal care and, in particular, its expertise in caring for marine mammals. Whales and dolphins at Vancouver Aquarium receive exceptional care and are content and thriving.

- The world's oceans are increasingly impacted by humans and many of the problems seem overwhelming. Whales and dolphins at the Vancouver Aquarium provide critical research opportunities to help protect wild populations facing unprecedented change. Some of these science needs would be impossible to achieve in the wild.

## Park Board Liaison Report September 2015

*The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in September 2015. The complete and official minutes can be found on the Park Board website.*

### OVERVIEW

This month's regular Committee and Board meetings were held on September 14 and September 28 at 2099 Beach Avenue. The first meeting of the month focussed on the 2015-2016 Fees and Charges for Recreation Services, and the second meeting agenda included items about public art installations, commemorative plantings, and an international sport event. In total, the Board reviewed 4 staff reports, 2 staff presentations, and 3 motions on notice.

### STAFF REPORTS

#### **Windstorm 2015 Update**

The Board received a presentation from staff on the effects of the windstorm that struck the Lower Mainland on August 29, 2015. The combination of recent dry weather and 61 km/h winds destroyed almost 350 trees in Vancouver. Vancouver Park Board's Urban Forestry team received 1,218 service calls for issues such as broken trees/branches, inspections, pruning, and full tree removal. The Urban Forestry team was commended for their quick response, hard-work, and dedication during the storm.

#### **2015-2016 Fees and Charges - Recreation Services**

The Board approved changes to the 2015-2016 Fees and Charges for Recreation Services, effective September 1, 2015. These changes apply to: indoor and outdoor swimming pools, fitness centres, arenas, racquet courts, outdoor sports facilities, and special event and filming permits. The increase reflects market conditions and provides for estimated inflationary cost increases in 2016.

#### **Ironman Triathlon Special Event**

The Board received a report on the Ironman Triathlon proposed for July 2016. The event would involve Sunday morning road closures in Stanley Park. The Commissioners had questions about the proposed route, particularly regarding public impacts and safety. The item was referred to staff to report back in October with further clarification on the event and route.

#### **Temporary Festive Light Installations - Morton and Alexandra Parks**

The Board approved the installation of temporary festive light installations at Alexandra and Morton Parks, a collaborative project between the West End Business Improvement Association and the Lumière Festival Vancouver Society. One of the objectives of Lumière 2015 is to animate and beautify key areas in the West End for the enjoyment of Vancouver visitors and residents. An illuminated 3D whale sculpture will be installed in Morton Park and illuminated umbrellas will be installed at the Haywood Bandstand in Alexandra Parks. Both displays will be in place for about two months.



### **"Home and Away" Public Art Installation - Empire Fields**

The Board approved the installation of the functional public art piece "Home and Away" after receiving the report back on the additional public consultation undertaken over the summer, which was requested by the Board in May 2015. This artwork was developed to reflect both historic structures of the site and the need for additional seating. Outcomes from the public engagement were primarily positive.

### **Commemorative Trees and Shrubs**

In response to the Board Motion approved in May 2015, staff reported back on historic, current, and proposed new initiatives for planting commemorative trees. The proposed initiatives include establishing a Tree Trust, an Adopt-A-Forest option, and a Legacy Tree Endowment. All initiatives support the Urban Forest Strategy and provide new fundraising, development, and marketing opportunities.

## **MOTIONS**

### **Marker of Change - the Women's Monument in Thornton Park**

The Board directed staff to propose solutions for the ongoing goose problem at the Marker of Change monument in Thornton Park. Staff are to report back to the Board no later than December 6, 2015, with a sustainable management plan.

### **Park Naming Committee for Empire Fields/Plateau Sports Park**

The Board agreed for staff to form a Naming Committee to recommend possible names for the newly reopened Empire Fields and Plateau Sports Park at Hastings Park.

### **Endorsing Vancouver's Living Wage Certification**

The Board asked staff to report back on possible implications of supporting Living Wage Certification, which was recently passed at City Council.

### July 11, 2016

#### STAFF REPORTS/PRESENTATIONS

##### **VanDusen Botanical Garden Receives Petal Certification**

A plaque was presented to the Board in recognition of the Petal Certification attained by the VanDusen Botanical Garden's Visitor Centre. This significant achievement, awarded by the International Future Living Institute, is an advanced measurement of sustainability, recognizing projects through performance categories called Petals. The VanDusen Visitor Centre achieved certification in the Petal categories of Site, Materials, Beauty and Inspiration. The Centre is one of only a handful of Petal Certified projects in British Columbia and the first in Vancouver.

##### **Trans\* and Gender Variant Inclusion Steering Committee - Member Appointments**

The Board approved the appointment of two new members to the Trans\* and Gender Variant Inclusion Steering Committee. Nominees were chosen based on their ability and experience in providing expert advice and insight from an inclusive range of the TGVI community. Filling these vacancies will strengthen the committee's ability to continue their work on the phased implementation of the recommendations in the "Building a Path to Parks and Recreation for All" report, which supports the Park Board's vision to be leaders in Parks and Recreation.

##### **Park Naming Committee Appointments**

The Board appointed 3 standing and 5 ad hoc members to the Park Naming Committee. Through a public engagement and research process, this Committee will identify and recommend park names for the sites known as Empire Fields, Plateau and Trillium.

##### **Northeast False Creek Park Design Advisory Group Appointments**

The Board appointed 12 individuals to the Northeast False Creek Park Design Advisory Group (PDAG). Collectively the Northeast False Creek PDAG will provide focused and valuable input, and enhance public engagement on this key addition to Vancouver's park and open space network.

Park Board Liaison Report March 2016

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in March 2016. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meeting was held on March 7, at 2099 Beach Avenue. The meeting included approval of a new pop-up park and funding for two Park Board reconciliation initiatives that respond to the TRC's Calls to Action. In total, the Board reviewed 4 staff reports, and 1 motion on notice.

STAFF REPORTS

5th & Pine Pop-up Park - Concept Plan

The Board approved the concept plan for a new temporary pop-up park at the corner of 5th Avenue and Pine Street. Informed by the 202 respondents who participated in the public consultation process from August to September 2015, it will include perimeter benches, tables, pollinator gardens, a water cistern, and bike racks. Recycled materials and wood from fallen trees in Stanley Park will be incorporated into the design. The pop-up park is expected to be complete in the fall of 2016.

Reconciliation Art Program - Corporate Sponsorship Funding

The Board approved a one-time expenditure of \$50,000 from the Corporate Sponsorship Fund to implement two of the Park Board's key reconciliation strategies: training on indigenous issues and reconciliation for staff and commissioners, and the launch of a new community-engaged reconciliation focussed arts program. With approval of these funds, all 11 of the reconciliation strategies approved by the Board in January 2016 will move forward.

Special Events Calendar 2016 - Major Events

The Board received the calendar of the 101 major events currently planned for 2016. This included a diverse line up of festivals, fundraisers, and sporting events. For a full list of the planned special events, please refer to the online [Board Report](#).

RBC Run for the Kids - Special Event

The Board unanimously approved the [RBC Run for the Kids](#) fundraiser to support childhood cancer research and treatment, as well as pediatric mental health initiatives at BC Children's Hospital. The event takes place in Riley Park on Sunday, June 5, 2016, and will host runners and walkers of all ages and abilities on a scenic 5km or 1km Fun Run route, followed by a carnival celebration.

MOTIONS on NOTICE

Zero Waste - Diversion Stations

The Board adopted a motion to have staff work with city departments to create a zero-waste strategy that would identify the best locations to place garbage and recycling stations at Park Board sites.

Park Board Liaison Report March 2015

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in March 2015. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meetings were held on March 2nd and March 23rd at 2099 Beach Avenue. The first meeting of the month focused on the 2014-15 budgets and the second meeting addressed some important health and safety matters. In total, the Board reviewed seven staff reports, one staff presentation, and two Motions on Notice.

STAFF REPORTS:

2015 Operating and Capital Budget

The Board approved the 2015 Operating and Capital Budget, subject to City Council approval. The 2015 Park Board Operating Budget of \$60,774,400 is comprised of \$113,382,600 in expenditures and \$52,608,200 in fee and program revenues. The 2015 Park Board Capital Budget is \$16.7 million.

Additionally, due to the increase in turf damage caused by the spread of the European chafer beetle, the Board amended the report recommendation to include a request to Council to approve a one-time increase of \$200,000 to the 2015 Park Board Operating budget for the development and implementation of a plan for chafer beetle control and turf repair.

2014-2015 Fees and Charges Changes

The Board approved new fees and charges for recreation facilities, parking, and golf that reflected current market rates. User fees and charges are levied to recover all or a portion of overall operating costs.

Musqueam Park Highbury Interceptor

The Board approved the location for Metro Vancouver's Highbury Interceptor Air Management Facility in Musqueam Park. The interceptor will significantly reduce odour and will include a public washroom. Technical constraints are such that Musqueam Park is the most feasible site for this facility and the recommended location within the park was identified after extensive public and stakeholder consultation.

Stanley Park Causeway Safety Improvements

The Board approved the safety improvements to the Stanley Park Causeway that were proposed by the Ministry of Transportation and Infrastructure. The plan includes a wider shared multi-use pathway on the eastern (northbound) side of the Causeway and a wider bicycle-only pathway on the western (southbound) side of the Causeway. Additionally, a safety rail will be installed between the pathways and vehicle lanes on both sides of the Causeway.

Parks Service Review

In response to the February 16th motion directing staff to develop a plan to identify needs and set temporary staffing levels to improve the care and appearance of parks and gardens city-wide, staff reported back with a presentation on the progress of the Parks Service Review. As part of their continuous improvement process, Parks Operations staff are focusing particular



attention on the following key areas in 2015: street horticulture, chafer beetle control, artificial turf maintenance, demand maintenance/invasive species management, and tree watering. To assist with addressing these priorities and to respond to fluctuations in seasonal maintenance requirements, 22 new temporary staff positions have been added for 2015.

Lease Renewals

The Board approved three lease renewals:

- ***Vancouver Curling Club*** - in operation since 1912, the club consists of approximately 1200 members and is a valued Park Board partner that provides recreation opportunities for a broad range of user groups; renewal for a 10 year lease in Hillcrest Centre approved.
- ***Mereloma Club*** - an amateur athletic organization founded in 1923; actively promotes athletics in the fields of rugby, soccer, softball, and cricket; renewal for a 10 year lease in the Connaught Park fieldhouse approved.
- ***Canadian International Dragon Boat Festival Society*** - a non-profit society responsible for coordinating the highly successful International Dragon Boat Festival held in False Creek on an annual basis; positive relationship with the Park Board for over 20 years; 3 year lease with 3 year option term for office space within the Creekside Community Centre approved.

MOTIONS ON NOTICE:

Vancouver Bluewater Task Force

The Board reviewed a motion proposing the establishment of a task force to review current recreational policies and suggest improvements as an advisory committee. After much discussion, the Board determined additional information was required and the motion was defeated.

Park Naming Committee for Trillium Lands

The Board unanimously agreed to convene a Neighbourhood Park Naming Committee as per Vancouver Park Board policy. The first park for the committee's consideration will be the site on Trillium Lands.

NEXT MEETINGS

The next regular Park Board Meetings are scheduled for April 13th and 27th at 2099 Beach Avenue.

The Board approved the 2015 Operating and Capital Budget, subject to City Council approval. The 2015 Park Board Operating Budget of \$60,774,400 is comprised of \$113,382,600 in expenditures and \$52,608,200 in fee and program revenues. The 2015 Park Board Capital Budget is \$16.7 million.

Additionally, due to the increase in turf damage caused by the spread of the European chafer beetle, the Board amended the report recommendation to include a request to Council to approve a one-time increase of \$200,000 to the 2015 Park Board Operating budget for the development and implementation of a plan for chafer beetle control and turf repair.

2014-2015 Fees and Charges Changes

The Board approved new fees and charges for recreation facilities, parking, and golf that reflected current market rates. User fees and charges are levied to recover all or a portion of overall operating costs.

Musqueam Park Highbury Interceptor

The Board approved the location for Metro Vancouver's Highbury Interceptor Air Management Facility in Musqueam Park. The interceptor will significantly reduce odour and will include a public washroom. Technical constraints are such that Musqueam Park is the most feasible site for this facility and the recommended location within the park was identified after extensive public and stakeholder consultation.

Stanley Park Causeway Safety Improvements

The Board approved the safety improvements to the Stanley Park Causeway that were proposed by the Ministry of Transportation and Infrastructure. The plan includes a wider shared multi-use pathway on the eastern (northbound) side of the Causeway and a wider bicycle-only pathway on the western (southbound) side of the Causeway. Additionally, a safety rail will be installed between the pathways and vehicle lanes on both sides of the Causeway.

Parks Service Review

In response to the February 16th motion directing staff to develop a plan to identify needs and set temporary staffing levels to improve the care and appearance of parks and gardens city-wide, staff reported back with a presentation on the progress of the Parks Service Review. As part of their continuous improvement process, Parks Operations staff are focusing particular



attention on the following key areas in 2015: street horticulture, chafer beetle control, artificial turf maintenance, demand maintenance/invasive species management, and tree watering. To assist with addressing these priorities and to respond to fluctuations in seasonal maintenance requirements, 22 new temporary staff positions have been added for 2015.

Lease Renewals

The Board approved three lease renewals:

- ***Vancouver Curling Club*** - in operation since 1912, the club consists of approximately 1200 members and is a valued Park Board partner that provides recreation opportunities for a broad range of user groups; renewal for a 10 year lease in Hillcrest Centre approved.
- ***Mereloma Club*** - an amateur athletic organization founded in 1923; actively promotes athletics in the fields of rugby, soccer, softball, and cricket; renewal for a 10 year lease in the Connaught Park fieldhouse approved.
- ***Canadian International Dragon Boat Festival Society*** - a non-profit society responsible for coordinating the highly successful International Dragon Boat Festival held in False Creek on an annual basis; positive relationship with the Park Board for over 20 years; 3 year lease with 3 year option term for office space within the Creekside Community Centre approved.

MOTIONS ON NOTICE:

Vancouver Bluewater Task Force

The Board reviewed a motion proposing the establishment of a task force to review current recreational policies and suggest improvements as an advisory committee. After much discussion, the Board determined additional information was required and the motion was defeated.

Park Naming Committee for Trillium Lands

The Board unanimously agreed to convene a Neighbourhood Park Naming Committee as per Vancouver Park Board policy. The first park for the committee's consideration will be the site on Trillium Lands.

NEXT MEETINGS

The next regular Park Board Meetings are scheduled for April 13th and 27th at 2099 Beach Avenue.

Park Board Liaison Report April 2015

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in April 2015. The complete and official minutes can be found on the Park Board website.

OVERVIEW

Regular Committee & Board meetings were held on April 13th and April 27th at 2099 Beach Avenue. Some items of note include: the Chair's Report highlighting an extensive list of community engagement events attended by Board members; a cheque presentation of \$138,486 to the Fire Fighters' Burn Fund for funds raised from the Bright Nights in Stanley Park train admissions; and the Park Board web stream launch on April 27th, which meant for the first time ever, Park Board public meetings can be watched live online with on-demand viewing available afterwards. This meeting also boasted a packed house, with an impressive public & media turn-out for the discussion on the Mount Pleasant skateboard facility location.

STAFF REPORTS:

General Manager's Report

The General Manager advised that Council meeting topics included: a report on the Oil Spill in English Bay; a presentation on the FIFA Women's World Cup Hosting Plan; the 2014 Annual Financial Report; recommendations for the 2015 Cultural, Community Services, Social and Innovation Grants; the Proclamation of Emergency Preparedness Week; and the City's Digital Strategy contract award for public Wi-Fi.

Healthy Local Food Field House Residencies - Norquay and Strathcona

The Board approved the licence agreements at both fieldhouses, with a goal to create communities that celebrate local food systems and build strong and resilient community connections.

Urban Agriculture - Barclay Heritage Square and Kensington Community Centre

The Board approved the new collaborative gardens at both Barclay and Kensington. These urban agriculture projects are in alignment with the Urban Agriculture Policy and support implementation of the Local Food Action Plan.

Queen Elizabeth Park Zipline

In honor of Queen Elizabeth Park's 75th anniversary, the Board approved the temporary installation of a zipline. The zipline will launch from a platform beside Bloedel Conservatory giving a sweeping view of the quarry rock gardens, downtown Vancouver, and the North Shore Mountains. Riders will land 190 meters from the launch destination.

Mount Pleasant Skateboard Facility Location

After receiving the staff presentation and recommendations, due to a significant amount of community feedback regarding the options proposed, along with the high number of speaking requests received, the Board decided further public consultation was required. Staff was directed to seek additional community input and the report was postponed to a future meeting where the public will be invited to speak on the topic.



Creating Greater Community Engagement

Staff presented highlights of the Park Board's many different community engagement activities, which included Commissioners' attendance at several community events, the launch of the Heron Cam and City Bird Week, increased social media presence, the "Parks and Recreation for All Campaign", and for the first time, live web-streaming of public Committee and Board Meetings. In the fall, the Park Board plans to launch Town Hall events that will bring meetings into different communities.

MOTIONS ON NOTICE

Zero Waste Water Bottle Policy

The Board considered a motion to develop a policy to ban the sale of bottled water in Park Board locations, and to increase water fountains and filling stations. After discussing possible impacts of banning bottled water sales, the Board agreed to only direct staff to investigate increasing water fountains and filling stations in Park Board facilities.

Vancouver Recreational Water Quality

The Board unanimously agreed to have staff work with the different levels of government to ensure that Vancouver's beaches and recreational waters are safe for its citizen to enjoy.

Cherry Tree Groves

The Board agreed for staff to identify some prominent park and boulevard locations that would be suitable for planting new cherry trees, while also aligning with the Urban Forest Strategy to increase the overall canopy cover and species diversity.

NEW BUSINESS

Park Board Emergency Response and Preparedness

Staff were directed to review the Park Board's role in responding to the April 8th fuel spill in English Bay, and to identify opportunities to aid and improve future response efforts.

NEXT MEETINGS

The next public meetings will be held at 7pm on May 11th and May 25th at 2099 Beach Avenue, with links available on the Park Board meeting and agenda pages for live online viewing.

Park Board Liaison Report October 2015

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in October 2015. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meeting was held on Wednesday, October 21st at 2099 Beach Avenue. The meeting focussed on the approval of two park development projects along with a special event report back. In total, the Board reviewed 3 staff reports.

STAFF REPORTS:

IRONMAN 5i50 Vancouver Triathlon - Special Event:

The Committee originally reviewed this special event request on September 28, 2015, but asked staff to provide further details regarding the proposed route, in particular to report back on safety issues and impacts on the public and park stakeholders. Staff presented additional information that addressed the Commissioner's concerns and the Committee unanimously approved the recommendations. An Ironman Triathlon will be held on Sunday, July 10, 2016.

McBride Park Improvements:

Staff proposed that the aging McBride Park playground be replaced and better situated, and that a community garden be added to the site. Committee approved both recommendations and passed a further motion to request that City of Vancouver staff investigate the possibility of closing of Waterloo Street, which currently bisects the park, so that the two segments of the park can be united.

Love Locks Sculpture Location and Development:

The Committee approved the concept of a Love Locks public art sculpture at their meeting on July 6th, however they requested that staff engage in further public consultation on possible locations for this installation. Based on the outcome of public consultation campaign, the Committee approved the recommendation of Queen Elizabeth Park as the preferred location.

MOTIONS:

Due to time constraints, the Motions on Notice were postponed for discussion at the next Regular Board Meeting scheduled for November 2, 2015.

NEXT MONTH'S MEETINGS

In the month of November, the Park Board will be meeting on November 2, and November 16, at 2099 Beach Avenue.

Park Board Liaison Report November 2015

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in November 2015. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meetings were held on November 2 and 16, 2015, at 2099 Beach Avenue. Both meetings addressed Planning and Development projects, as well as contract awards. In total, the Board reviewed 4 staff reports, 2 staff presentations, and 4 motions on notice.

STAFF REPORTS/PRESENTATIONS

Vancouver Whitecaps FC - Special Presentation

Colby Fackler, Whitecaps FC Director of Sales and Service, was present to extend a special "thank you" to the Board for their ongoing support and promotion of community sports. Commissioners were presented with official Whitecaps Play off t-shirts.

Planning and Development Projects

- ***17th and Yukon New Park Design/Build Contract*** - The Board approved the contract award to Horizon Landscape Contractors for construction of the new mini park at 17th and Yukon. The park will include an accessible playground structure.
- ***Sunset Park Revised Concept Plan*** - The Board approved the revised concept plan for Sunset Park that would reconnect the community centre, ice rink and green space. The final concept requires moving the off-leash dog area and a portion of the Park Board Operations Works Yard. A spray park and youth amenity features are to be added to the park. The Board also recommended that Sunset Park be included in the upcoming Aquatic Study for consideration as a possible pool site, and that staff explore options to relocate some, or all, of the existing Works Yard in order to free-up park space for other uses.

Contract Awards

- ***Hillcrest-Riley Park Improvements Construction Contract*** - The Board approved the contract award to Wilco Civil Inc. for the Hillcrest-Riley Park improvements. The improvements in the Hillcrest area include a recycled synthetic turf field and an asphalt drive for the overflow parking at Nat Bailey Stadium. Riley Park improvements include walking trails, tree plantings, a new plaza area, and a community garden.
- ***Harbour Green Park Restaurant Contract Award*** - The Board approved a 10-year lease with the Sequoia Company of Restaurants to operate a restaurant at the Harbour Green Park site, with the understanding that the structure is to be no higher than two storeys. McDougall Holdings Ltd. was selected as the construction company for the project.



Vancouver Parks Foundation - Implementation Plan

The Board approved the draft implementation plan for a Vancouver Parks Foundation. The primary function of the foundation will be to engage the community to support our parks, activities, and recreation facilities. The foundation would also support programs and projects that are not addressed through capital funding. There is substantial planning still to be done and staff will report back in late 2016 with the complete plan for final approval.

QE Park Zipline Pilot Outcomes

The Board received a presentation on the temporary zipline that operated at Queen Elizabeth Park over the summer. The pilot operated for 87 days and carried 23,564 riders, and based on the overall feedback received from 822 survey respondents, the zipline was well received.

MOTIONS

Serving Up a Fresh Concession Strategy

The Board directed staff to look into other concession operating models. The focus will be on local, sustainable, diverse, and affordable menu options. Staff will report back in May 2016.

Water Conservation Strategy

The Board directed staff to report back with a water conservation strategy, focusing on options to reduce water usage and to reuse/recycle gray water, in order to better protect against future droughts like the one experienced this past summer.

Multimodal Parking and Revenue Generation at the New Smithe and Richards Park Site

The Board referred this motion to a future Committee Meeting in order to hear from speakers, pending the outcome of the community consultation report.

Vancouver Park Board Public Consultation Standards Policy

The Board approved for staff to assemble a comprehensive public consultation policy by the end of 2016. Staff will report back to Board on the current consultation practices in the coming months.

NEW BUSINESS

Security Plan for Vancouver Parks

Due to the recent theft at the Stanley Park Miniature Train's Bright Nights site, the Board asked staff to propose a comprehensive security plan by April 2016. The plan will consider security cameras, limited access to certain areas, and increased security. There will also be immediate action taken to protect further loss at the Stanley Park "Bright Nights", the VanDusen Garden's "Festival of Light", and the Bloedel Conservatory "Enchanted Nights" events.

NEXT MONTH'S MEETINGS

In the month of December, will be meeting on Tuesday, Dec 9th for a Special Meeting on the 2016 Budget, as well as on Monday, Dec 14th for their regular Committee and Board meetings. Both meetings will be held at the Park Board offices at 2099 Beach Avenue.

STAFF REPORTS/PRESENTATIONS

VanDusen Botanical Garden Receives Petal Certification

A plaque was presented to the Board in recognition of the Petal Certification attained by the VanDusen Botanical Garden's Visitor Centre. This significant achievement, awarded by the International Future Living Institute, is an advanced measurement of sustainability, recognizing projects through performance categories called Petals. The VanDusen Visitor Centre achieved certification in the Petal categories of Site, Materials, Beauty and Inspiration. The Centre is one of only a handful of Petal Certified projects in British Columbia and the first in Vancouver.

Trans* and Gender Variant Inclusion Steering Committee - Member Appointments

The Board approved the appointment of two new members to the Trans* and Gender Variant Inclusion Steering Committee. Nominees were chosen based on their ability and experience in providing expert advice and insight from an inclusive range of the TGVI community. Filling these vacancies will strengthen the committee's ability to continue their work on the phased implementation of the recommendations in the "Building a Path to Parks and Recreation for All" report, which supports the Park Board's vision to be leaders in Parks and Recreation.

Park Naming Committee Appointments

The Board appointed 3 standing and 5 ad hoc members to the Park Naming Committee. Through a public engagement and research process, this Committee will identify and recommend park names for the sites known as Empire Fields, Plateau and Trillium.

Northeast False Creek Park Design Advisory Group Appointments

The Board appointed 12 individuals to the Northeast False Creek Park Design Advisory Group (PDAG). Collectively the Northeast False Creek PDAG will provide focused and valuable input, and enhance public engagement on this key addition to Vancouver's park and open space network.

- An administrative report on the Greenest City Action Plan - Implementation Update will be presented by The Sustainability Group.

Park Board Liaison Report February 2015

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in February 2015. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meetings were held on February 1 and February 22 at 2099 Beach Avenue. The first meeting of the month focussed on Parks Development and Planning projects and the second meeting addressed a broad spectrum of parks and recreation matters. In total, the Board reviewed 4 staff reports, 1 staff presentation, and 5 motions on notice.

STAFF REPORTS

Biodiversity Strategy

The Board approved the Biodiversity Strategy, with the goal of increasing the amount and ecological quality of Vancouver's parks and natural areas. The Board also directed staff to implement priority actions such as: acquiring park land, planting trees, dealing with invasive species, restoring shoreline and sub-tidal habitats, returning native forests to large parks, and many education and stewardship programs.

Vanier Park West Float and Launch Upgrade - Construction Contract Award

The Board approved to enter into a contract with JJM Construction Limited for the Vanier Park West Float and Launch Upgrade. Upgrades to the East float were completed in 2014 due to the aging facilities. With completion of the West float by April 2016, recreational users will once again be able to use the Vanier Park launch.

Killarney Seniors Centre - Design Build Contract Award

The Board unanimously approved the award of the contract to build the new Killarney Seniors Centre to Ventana Construction Company. Ventana's proposal provided best overall value and indicated various sustainable elements that will aid in reducing energy consumption for this project by a total on 35%.

NEFC Park Advisory Group - Terms of Reference

The Board approved the inception of a park design advisory group. The advisory group will be Board appointed after applications are received from a public call of interest. The Board also approved the terms of reference, which outlines roles and responsibilities for the group.

2015 Special Events Report Back

The Board received an overview on 6 new Special Events that were approved for 2015. The presentation provided highlights of the 3 events that took place as planned, as well as a recap of the reasons why 3 of the approved events did not proceed as planned. Organizers of the cancelled events did express thanks for the Board's support and that they look forward to future possibilities.



MOTIONS:

Park Board Ice Rink Strategy

The Board approved the development of an Ice Rink Strategy for Vancouver. Staff were directed to report back in the fall of 2016 with comprehensive information on such topics as: supply and demand, user challenges, user groups, potential for new rinks, as well as twinning existing rinks.

Serving Our Seniors

The Board unanimously passed the motion to create a comprehensive strategy that addressed how the Park Board can best serve its senior community through its facilities, services, and programs. The strategy will be inclusive of the City's diverse cultural groups and needs, as well as explore partnership opportunities that are beneficial to seniors. Staff will report back to the Board by the end of 2016.

Park Board Recognition of Dal Richards' Life and Legacy

The Board approved a motion to have staff identify Park Board assets that could be used to recognize the life and work of Dal Richards, a legendary Vancouver big band leader who passed away on December 31, 2015.

Marking National Flag of Canada Day 2017

The Board directed staff to look at the feasibility of installing a permanent flag pole on or beside Bloedel Conservatory to mark the 150th anniversary of Confederation on National Flag of Canada Day in 2017, including a plan for a permanent marker and celebration on that day.

Creekside Park Delivery

The Board agreed to urge Mayor and Council to deliver some or all the Creekside Park Extension on an expedited basis in order to alleviate the critical shortage of available green space for residents in the Northeast False Creek area. The Board also directed staff to create a communications plan that will outline the timeline and process of the park development.

NEW BUSINESS

It was noted that the Vancouver Public Library was the winner of the 2016 Biblibre International Library Marketing Award from the International Federation of Library Associations. Applications were received from 26 countries around the world. This prestigious award honors organizations that have implemented creative, results-oriented marketing projects or campaigns that promote the library and information services industry.

STAFF REPORTS/PRESENTATIONS

Public Bike Share Stations in Parks

The Board approved the 11 proposed locations for Mobi (Public Bike Share) stations in parks. The initial sites include Kits Beach Park, Sunset Beach, English Bay, and Stanley Park (subject to First Nations approval). All are to be located on existing hard surfaces, except one on compacted gravel, and there will be no reduction in or impacts on green space. The stations can be temporarily removed to accommodate special events at no cost to the Park Board.

GM'S REPORT

Malcolm Bromley, General Manager, advised on the following:

- A report going to council titled "Making the City of Vancouver a Living Wage Employer" will be discussed at their next meeting; the report asks that the Park Board endorse its recommendations.
- The Community Centre Associations and Park Board staff will be attending a Workshop on Sep 24/16 to review the draft Joint Operating Agreement.
- The Park Boards Tree Sale is happening now with online sales of a variety of trees that can be picked up on Oct 1 & 2 at Hillcrest Community Centre
- The new Director of Recreation, Donna-Lynn Rosa, will be starting her position with the Park Board on Sep 26, 2016.

MOTIONS

Seniors' Centre to Serve the Sunset Community in South Vancouver

The Board directed staff to investigate a potential site appropriate for the development of a seniors' centre nearby or adjacent to the current Sunset Community Centre. Staff were asked to explore funding models and source funding from different levels of Government. Chair Kirby-Yung shared a letter of support from the Honourable Harjit S. Sajjan, Vancouver South MP.

A Vancouver Park Board Youth Ranger Program

The Board directed staff to investigate creating a Park Board Youth Ranger Program which would allow youth to learn and participate in environmental responsibility, sustainability, civic leadership, and community engagement. This program could also help support a current initiative to convert a fieldhouse into a "junior ranger station". The implementation target for this pilot program is the summer of 2017.

Park Board Liaison Report April 2016

The following information is intended to provide an overview of the Board's governance work at the regular Board and Committee meetings held in April 2016. The complete and official minutes can be found on the Park Board website.

OVERVIEW

This month's regular Committee and Board meeting was held on April 18, at 2099 Beach Avenue. The first meeting of the month was cancelled out of respect for staff and family mourning the loss of Jody Taylor, a Park Board arborist who was fatally injured while at work. On April 18, the Board honoured Jody Taylor with a tribute (can be viewed online) as well as dealing with business rescheduled from the cancelled meeting. In total, the Board reviewed 3 staff reports and 3 staff presentations.

STAFF REPORTS:

Tribute to Jody Taylor

On March 31, 2016, the Park Board lost a dedicated and long serving member of its team in a workplace accident. Jody Taylor was an arborist who worked for the Park Board for almost 16 years. Mr. Taylor was a member of a 5 person crew that was removing a hazardous tree at Connaught Park when the incident occurred. Jody was also a musician, photographer, and most importantly a devoted father. He is deeply missed by his colleagues, friends, and family.

The General Manager presented a gift from the Park Board to Jody's 10-year-old daughter and Jody's crew presented his mother with a memory book created by his colleagues. The Chair also announced that on April 28, 2016, the National Day of Mourning, the Park Board will be holding a memorial for Jody Taylor with a tree and bench dedication in Stanley Park. The Day of Mourning commemorates workers who have been killed, injured, or suffered illness due to workplace related hazards and incidents.

Bright Nights in Stanley Park - Burn Fund

Representatives from the BC Professional Fire Fighters' Burn Fund attended for an official cheque presentation from the Vancouver Park Board in the amount of \$149,855. These funds were raised through the Bright Nights in Stanley Park train admission revenues. It was noted that 2015 was the 18th year the Park Board partnered with the Burn Fund to organize the popular seasonal light show.

Creekside Paddling Centre License Agreements

The Board approved the operating agreements with the Canadian International Dragon Boat Festival Society and the British Columbia Mobility Opportunities Society to operate the Creekside Paddling Centre. The facility has been undergoing construction throughout 2015 and is scheduled to open at the end of April 2016. Both societies provide recreational programming benefitting residents of Vancouver.

Economic Access Policy & Leisure Access Program Update

The Board reconfirmed its support for the Leisure Access Program (LAP) and approved updates to the Economic Access Policy report that support current services and practices. This policy ensures that all residents of the City of Vancouver have the opportunity to lead healthier



lifestyles and build community connections through access to recreation services and programs.

New Brighton Salt Marsh - Preferred Concept Plan

The Board approved the preferred concept plan for the creation of a salt marsh at New Brighton Park. The focus is to restore habitat for fish and wildlife in Burrard inlet. There will be a small island, forest and shrubs consisting of native plants, two viewing platforms, and a beach grass meadow. Based on community feedback, the plan includes moving the off-leash dog area to the west side of the park; the dog park will be fenced and grassy as well as having a separate fenced off-leash area with access to the inlet. The Project is expected to be complete in the spring of 2017.

Park Board Public Consultation - Current Practices

The Board received a presentation on the current public engagement methods used by staff. Some examples of the practices used include: open houses, stakeholder and focus group workshops, online surveys, and public meetings. Staff identified opportunities for improvement, including incorporating the IAP2 Spectrum into the Park Board policy, developing a strategy that engages underrepresented groups, and optimizing facilities for public engagement. Staff will continue to explore best practices and develop a new public engagement standards Policy by the end of the year.

STAFF REPORTS/PRESENTATIONS

Love Locks Sculpture - Final Concept

The Board approved the final concept plan put forward by staff after extensive public engagement. The sculpture is titled "Love in the Rain" by Bruce Voyce, a celebrated local artist residing in the Strathcona neighbourhood. The sculpture design is engaging, aesthetically pleasing, and inclusive to all with intentionally ageless and genderless figures.

South False Creek Seawall - Park Upgrades and Tree Replacement

The Board supported the many park improvements proposed for along the South False Creek Seawall, with the primary focus on improving safety for all users. Seawall & park upgrades include: widening & separating walking and cycling paths; encouraging faster riders to use the Seaside Bypass; adding lighting, dog park fencing, and a washroom facility to Charleson Park; replacing 34 failing cherry trees with new, healthy trees; adding perennial beds.

Synthetic Turf Field Replacement Contract - Oak Meadows & Kerrisdale Parks

The Board approved entering into a contract with Carpell Surfaces Inc. to install synthetic turf at the two above noted parks. The Board received detailed information on three types of infill: Greenplay Organic infill (cork), Recycled Crumb Rubber, and Thermoplast Elastomer (TPE). After considering durability, health, environmental impacts, and costs, the Board selected Thermoplast Elastomer (TPE) infill for the new field at Kerrisdale, with the field at Oak Meadows not requiring infill.



Beedie Development Group (BDG) Private Special Event

The Board approved BDG's use of the garden space between the Malkin Bowl and Stanley Park Pavilion, facilitating the connection between the two venues which have been rented for BDG's special private concert event on July 9, 2016. As part of the compensation agreement, BDG will be repainting Malkin Bowl and donating decorative stanchions.

GM'S REPORT

Malcolm Bromley, General Manager, advised that an administrative report on the 2016 Q1 Capital Budget Adjustments and Closeouts would be considered at the May 3, 2016 City Council. The administrative report will include the closeout for the Nat Bailey Stadium.

Park Board related items at the May 4, 2016 Standing Committee on Policy and Strategic Priorities include:

- Seaside Greenway - South False Creek - Burrard Bridge to Cambie Bridge
- Meraloma Club - New Liquor Primary Licence Application and Outdoor Patio - Liquor Establishment Class 7 - Private Club.

MOTIONS

Arbutus Greenway

The Board approved a motion to seek a commitment from the City of Vancouver for the creation of new public parks and green space along the entire (approximately) 9-kilometre Greenway, and to ensure that the Park Board would be an integral part of the Arbutus Greenway planning team. This commitment would support the Greenest City Action Plan with the goal of creating a lasting legacy for Vancouver by developing one of the longest linear parks in North America.

Access to Park Board Services Without Fear

The Vancouver Park Board strives to ensure all residents of Vancouver have open access to its parks, recreational facilities, and services but recognizes that some residents may be fearful to access these services due to having uncertain immigration status. The Board affirmed its commitment to respond to the diverse needs of people arriving and living in Vancouver and directed staff to develop a policy that is consistent with the spirit and objectives of the "Access to City Services without Fear for Residents with Uncertain or No Immigration Status Policy".

Water Conservation Measure

The Board discussed a motion that proposed the re-activation of an unused water reservoir in the VanDusen Botanical Garden that could potentially use captured water during times of restricted water use. The motion was referred to staff for further investigation.

Zero Waste - Organic Infill Artificial Turf Fields

In light of the Board decision to use TPE infill for Kerrisdale Park, the proposed motion to implement the use of organic materials instead of crumb rubber on all new and replacement artificial turf fields in Vancouver was withdrawn.



MAY 16, 2016

STAFF REPORTS/PRESENTATIONS:

East Fraser Lands (EFL) Consultant Contract

The Board approved the award of a consultant contract to Space-2-Space Design Inc. for the design of approximately eight acres of parks in the East Fraser Lands, which lie in the southeast corner of Vancouver on the Fraser River. The plan includes four new parks that will be designed to best serve the surrounding community.

Beach Chair & Umbrella Rental at English Bay Contract Award

The Board approved a two-year pilot program agreement for Blue Hole Investments to operate a beach chair and umbrella rental service at English Bay Beach. The proposed program will introduce a new and valued service, enhance customer convenience, and deliver additional sun protection at a popular Vancouver beach.

Freedom of Information and Protection of Privacy By-Law

The Board reviewed and approved the repeal and replacement of the Freedom of Information and Protection of Privacy By-law to align the by-law with the provincial legislation. A By-Law will be brought forward to the Commissioners at a later date for their consideration of repeal and replacement.

GM'S REPORT

The Park Board General Manager advised that consideration of the Meraloma Club's application for a liquor licence was postponed by the Standing Committee on Policy and Strategic Priorities on May 4, 2016, and will be considered at the May 18, 2016, meeting. A presentation from Sanitation on Public Realm Cleanliness from Waste Management is also scheduled.

MOTIONS

Pioneer Place (Pigeon Park) Clean-up Strategy

The Board discussed a motion directing staff to work with the local community to bring Pigeon Park to the standard of other Vancouver neighbourhood parks, including looking at options to wrap the utility box, install a creative needle disposal box, review community art installation opportunities, install a 3 tiered water fountain, create a local ambassador program, review a waste management plan, fix current benches, and revitalize the horticulture. The motion was referred to staff to report back to the Committee.

Official Tree for Vancouver

Recognizing that the City of Vancouver does not have an official tree, the Board approved a motion for staff to launch an official tree nomination process that will include opportunities to engage the public and local students. Final selection will be done by a panel with expertise in forest diversity, with the winning tree announced during Tree Week 2017. The City of Vancouver will be asked to formally endorse and adopt the selected tree.



MAY 30, 2016

STAFF REPORTS/PRESENTATIONS

New Downtown Park at Smithe and Richards

The Board unanimously approved the final design plan for the new park at Smithe and Richards that was a result of extensive public consultation via open houses, Pop-Up City Hall, and surveys. Park amenities include a large public plaza, an overhead walkway that provides a bird's eye view of the park, and an accessible network of paths. There will be a food and beverage amenity to anchor and activate the public space and the site will also include public washrooms and storage space.

GM'S REPORT

The Park Board General Manager noted the following events scheduled for May 31, 2016:

- A media event to announce the new downtown park at the Smithe and Richards site
- A concession strategy focus group meeting at the Park Board office
- The first consultation dialogue session with the community centre associations.

Mr. Bromley also announced that Shawna Wilton has accepted the position of Deputy General Manager. Shauna will maintain her current responsibilities pending the hire of the new Director of Recreation Services.

BY-LAWS

Freedom of Information and Protection of Privacy By-Law

The Board enacted a new Freedom of Information and Protection Privacy By-Law to align with the current FOIPP Act and to replace the prior by-law that included many outdated items.



MOTIONS

Expediting New Outdoor Pools

The Board approved a motion to direct staff to explore quick start strategies, including the reallocation of existing capital funding, to expedite the construction of new outdoor pools in Vancouver.

Barrier-Free BC

The Board unanimously agreed to formally support the Barrier-Free BC movement that calls upon BC's Legislative Assembly to enact a strong and effective British Columbians with Disabilities Act, with the aim to name BC as the most progressive province in Canada for people with disabilities by 2024.

>

> As per the messages left to each of you via Clint and myself, unfortunately we have some sad news today at the Aquarium.

>

> Last evening around 7pm Hana our female Pacific white-sided dolphin passed away.

>

> As you know last week Hana was diagnosed with a gastro-intestinal blockage that was rapidly progressing and would have certainly led to her death. Just 2 or 3 years ago there were no options to treat, however recent successful advances in surgeries on dolphins provided a glimmer of hope and so last Thursday night the first-ever enterotomy (bowel surgery) on a Pacific white-sided dolphin under general anesthesia was performed by a team of leading specialists from across the continent.

>

> The procedure itself was successful however the condition of the bowel was of grave concern to Dr. Marty Haulena and the surgeon who performed the operation but both agreed that there was a chance, however small, that aggressive post-operative treatment and her own strength might just pull her through.

>

> The marine mammal care team assisted by other volunteers nursed her day and night, 24-hours a day walking in waist deep water, supporting her, providing familiar encouraging words and close gentle contact.

>

> By Saturday morning there were some small signs of improvement enough to raise our care team's spirits - a little glimmer of hope - however by that same evening some of her physiological parameters started to worsen. Unfortunately, on Sunday we had a rapidly deteriorating dolphin.

>

> Although everyone knew that it was a miracle that she made it through the surgery and that her recovery was a very unlikely long shot, her loss still comes as a devastating blow to those that loved her and put so much of themselves into her care.

>

> We owe a great debt of thanks to the veterinary medical specialists that were assembled who are second to none and to the marine mammal veterinary community that provided thoughtful comment and support. We are fortunate to also have an incredible animal husbandry team -- this is the team who cares for them day in and day out, and the ones who spend long, late hours caring for them when they are ill.

>

> Hana was a dolphin that was already given a second chance. Rescued in Japan after being found entangled, emaciated and very sickly, she was rehabilitated and deemed non-releasable. The Vancouver Aquarium was able to offer her a home along with another rescued dolphin, Helen. Together these dolphins have given us new insights into how dolphins detect fishing nets and use sonar, they have inspired millions of visitors connecting them to issues that these animals face in the wild. Most poignantly, perhaps, Hana's legacy will be the huge medical advance informing dolphin surgeries and providing hope in the future to sick animals.

DFO will proceed with an announcement tomorrow regarding the decision that Chester will remain at the Vancouver Aquarium.

If you will recall, in January 2015, Fisheries and Oceans Canada established an external scientific panel to evaluate and help make an informed decision about Chester, the false killer whale (*Pseudorca crassidens*), and his long-term care. The result of that review is that Chester will stay here at the Vancouver Aquarium.

The decision was made prior to the death of Hanna. The habitat must be prepared for Chester which includes some work around its perimeter. This work will raise questions from visitors and staff need to be briefed on why the work is taking place. At this point, very few in the organization are aware of this decision. We need to be able to communicate it out and in order to do that DFO needs to make its announcement.

Talking points are attached FYI. The Media advisory will be distributed at 8:30 a.m. Please feel free to reach out should you have any questions or need further information.

Dear Aquarium Supporter,

It's with immense sadness that I share the passing of beluga whale Aurora. As detailed last week and through [daily updates](#) on her condition, Aurora had been sick for the past two weeks, showing symptoms of abdominal cramping, loss of appetite and lethargy. Our marine mammal care team, under the guidance of head veterinarian Dr. Martin Haulena, and a host of veterinary specialists, pathologists, marine biologists and other experts from around-the-world, had been working relentlessly to provide treatment, investigate her symptoms, adjust her medication, and ensure she had therapeutic care.

After a determined around-the-clock effort by animal care staff and the veterinary team, she slipped away yesterday evening surrounded by the people who loved her, some of whom have cared for her since she first arrived in 1990. To our team, Aurora was a part of our family and her loss is absolutely heartbreaking. The marine mammal care team, who worked night and day to care for her, are our true heroes, even if we lost the battle.



We will continue to explore the cause or causes of Qila and Aurora's sudden illness — a necropsy will be conducted by Dr. Haulena and he will continue to consult with other specialists across the globe as we continue the investigation.

Named after the aurora borealis, or northern lights, Aurora immediately won hearts and inspired generations of visitors, employees and volunteers with her curious nature and gentle personality. Along with the other belugas at the Aquarium, including her daughter Qila, Aurora taught millions about her incredible species and its rapidly changing ecosystem in the wild.

The past two weeks have been extremely difficult and today's loss has left a hole in our hearts. On behalf of our team of 1,500 staff and volunteers, we'd like to thank everyone who has reached out to us with warm messages of support and offers of help. You've shared countless stories of how Aurora and Qila have impacted you and your family and we're grateful to everyone who has shared those connections with us. Please continue doing so.

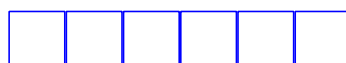

Subject: Update on Corky



Dear Aquarium Supporter,

We are greatly saddened to share that Corky, the rescued sea otter found near Tofino in August, succumbed to his injuries early Wednesday morning. He underwent first-of-its-kind surgery on Monday night to try and save his life due to the injuries he sustained from a suspected boat strike. Despite heroic efforts by the Vancouver Aquarium Marine Mammal Rescue Centre and an international team of veterinarians, Corky was unable to recover.

Corky was rescued near Tofino on August 13 by a team from the Rescue Centre. Head veterinarian Dr. Martin Haulena said the animal had a fractured rib that led to subcutaneous emphysema, or air trapped under his skin. Unable to dive or forage for food, Corky faced certain death in the wild, and was brought to the Rescue Centre for treatment. Once the emphysema subsided, follow-up tests showed one of his kidneys had also likely ruptured.

On Monday night, he underwent the first-ever nephrectomy (removal of a kidney) for a sea otter, a cystotomy to remove blood clots from his bladder, as well as the first-known blood transfusion for a sea otter. Previously rescued sea otter Elfin, one of four otters at the Vancouver Aquarium, was the blood donor for the transfusion. The procedure was performed by Dr. Alex Aguila, a veterinary surgeon from the Animal Surgical Clinic of Seattle, Dr. Lesanna Lahner, head veterinarian for the Seattle Aquarium, and Dr. Karisa Tang, Vancouver Aquarium veterinary fellow.

"Corky's case was such an inspiring rescue effort," said Emily Johnson, manager of the Aquarium's Marine Mammal Rescue Centre, presented by Port Metro Vancouver. "The surgery was nothing short of amazing, and I thought he just might pull through. He seemed to have that much will. He was a special little guy."

"We knew his condition was critical, and that the odds were against him, but we gave it everything we had, including trying new surgery techniques to save him," said Dr. Martin Haulena, head veterinarian at the Vancouver Aquarium Marine Science Centre. "We learned so much from him. His treatment contributes to a greater body of veterinary knowledge which will help us with future rescue efforts."

The work conducted through our Marine Mammal Rescue program sets the standard for many such operations around the world. Extraordinary pioneering efforts to save Corky and other similar cases provide incredible opportunities to ultimately uncover better ways to treat, prevent, diagnose, and rescue marine mammals. Subject: Vancouver Aquarium - Pacific White sided Dolphin - Hana

John,

I have some very sad news to pass along. Last evening around 7pm Hana our female Pacific white-sided dolphin passed away. Last week Hana was diagnosed with a gastro-intestinal blockage that was rapidly progressing and would have certainly led to her death. Just 2 or 3 years ago there were no options to treat, however recent successful advances in surgeries on dolphins provided a glimmer of hope and so last Thursday night the first-ever enterotomy (bowel surgery) on a Pacific white-sided dolphin under general anesthesia was performed by a team of leading specialists from across the continent.

The procedure itself was successful however the condition of the bowel was of grave concern to Dr. Marty Haulena and the surgeon who performed the operation but both agreed that there was a chance, however small, that aggressive post-operative treatment and her own strength might just pull her through.

Although everyone knew that it was a miracle that she made it through the surgery and that her recovery was a very unlikely long shot, her loss still comes as a devastating blow to those that loved her and put so much of themselves into her care.

Subject: Walter the Sea Otter



Dear Aquarium Supporter,

It is with deep sadness that we let you know Walter the sea otter passed away peacefully in his sleep last night.

Walter came to the Vancouver Aquarium's Marine Mammal Rescue Centre in October of 2013. He was rescued from Tofino with the help of Fisheries and Oceans Canada after he was found with gunshot wounds that caused blindness and other severe injuries. After several procedures at our Rescue Centre to deal with his injuries, we provided a home to Walter at the Aquarium, as he needed long-term care.

He was already an old otter when he was rescued and this was compounded by challenging issues due to his blindness and injuries, but our marine mammal staff did a terrific job making his last few years pain free and comfortable. He was introduced to, and interacted with, our female otters on a regular basis.

In the last month or so, and as expected for an aging otter (he was estimated to be between 15 – 17 years old), his activity had begun to slow down. He could not groom as well, and he started experiencing changes to his body condition. The marine mammal staff worked very hard to adjust their schedules, modify his habitat to be more suitable for an older, weaker otter, and adjust his diet.

Walter's story captivated people around the world. So many of you shared warm thoughts and wishes, and supported his rehabilitation and ongoing care with generous donations. While we are sad at Walter's loss, we are grateful for the outpouring of support over the last two years. Without all of you, our team would not be able to do what they do – to care for injured or abandoned marine mammals and to have made Walter's last few years as safe and comfortable as they were.

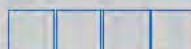

The procedure itself was successful however the condition of the bowel was of grave concern to Dr. Marty Haulena and the surgeon who performed the operation but both agreed that there was a chance, however small, that aggressive post-operative treatment and her own strength might just pull her through.

The marine mammal care team assisted by other volunteers nursed her day and night, 24-hours a day walking in waist deep water, supporting her, providing familiar encouraging words and close gentle contact.

By Saturday morning there were some small signs of improvement enough to raise our care team's spirits - a little glimmer of hope - however by that same evening some of her physiological parameters started to worsen. Unfortunately, on Sunday we had a rapidly deteriorating dolphin.

Although everyone knew that it was a miracle that she made it through the surgery and that her recovery was a very unlikely long shot, her loss still comes as a devastating blow to those that loved her and put so much of themselves into her care.

We owe a great debt of thanks to the veterinary medical specialists that were assembled who are second to none and to the marine mammal veterinary community that provided thoughtful comment and support. We are fortunate to also have an incredible animal husbandry team -- this is the team who cares for them day in and day out, and the ones who spend long, late hours caring for them when they are ill.

Hana was a dolphin that was already given a second chance. Rescued in Japan after being found entangled, emaciated and very sickly, she was rehabilitated and deemed non-releasable. The Vancouver Aquarium was able to offer her a home along with another rescued dolphin, Helen. Together these dolphins have given us new insights into how dolphins detect fishing nets and use sonar, they have inspired millions of visitors connecting them to issues that these animals face in the wild. Most poignantly, perhaps, Hana's legacy will be the huge medical advance informing dolphin surgeries and providing hope in the future to sick animals.

## **VANCOUVER AQUARIUM PROVIDES UPDATE ON PACIFIC WHITE-SIDED DOLPHIN**

**VANCOUVER, B.C.** – Despite having received unprecedented surgical treatment by a world-class team of veterinarians, Hana, a Pacific white-sided dolphin at the Vancouver Aquarium Marine Science Centre, passed away on Sunday evening. Vancouver Aquarium head veterinarian Dr. Martin Haulena will provide a briefing to media.

**TALKING POINTS: HANA (May 25, 2015 – NOT FOR DISTRIBUTION)**

- In 1996, Vancouver Aquarium became the first aquarium in the world to make a commitment to no longer capture cetaceans from the wild for display. We now only accept and care for whales, dolphins and porpoises that were born in an aquarium or were rescued and deemed non-releasable by an appropriate government authority.
- Vancouver Aquarium is the only marine mammal rescue centre in Canada and the only real hope for stranded, sick and injured marine mammals in B.C. Only by working with whales and dolphins in human care has the Aquarium been able to refine the professional skills needed to rescue marine mammals like BC's endangered and threatened killer whales.
- The few well-cared for cetaceans at the Vancouver Aquarium directly contribute to research efforts that help to conserve wild populations.

**Pacific white-sided dolphins**

- Hana had been at the Vancouver Aquarium Marine Science Centre since 2005. She arrived from Enoshima Aquarium where she had been in care for injuries sustained from entanglement in a fixed-location fishing net off the east coast of Japan in 2003. As the only marine mammal rescue centre in Canada, Vancouver Aquarium provides long-term care to several rescued marine mammals; it offered a home to her and to Helen, another rescued Pacific white-sided dolphin, after Japanese officials deemed them unreleasable due to the extent of their injuries, which would have put them at a disadvantage in the wild.
- Animals at the Vancouver Aquarium do not come from drive fisheries in Taiji or from any drive fishery. The Alliance of Marine Mammal Parks and Aquariums condemns the inhumane killing of dolphins and other cetaceans in the Japanese drive fisheries. As an Alliance member, the Vancouver Aquarium Marine Science Centre does not support, fund, or acquire animals from drive fisheries.
- Pacific white-sided dolphins at the Vancouver Aquarium participate in research to help scientists understand how dolphins perceive nets—a study we hope will lead to the development of dolphin safe nets, ultimately protecting other wild dolphins from a similar fate.
- Dolphins at the Vancouver Aquarium, like those in almost all aquariums, play a direct and vital role in engaging people and helping them connect to the broad range of issues affecting animals living in our oceans. Climate change, overfishing, pollution and marine debris are all are very real and large threats to dolphins, and to other ocean dwelling animals. Presenting these issues in the context of the impacts humans are having on living animals makes the message much more effective and drives change.

- All of the animals on display, and the wild ecosystems they live in, are impacted by human actions. This is something we all can do something about. The increasing public interest and participation in conservation programs is testimony to people wanting to help. It's up to institutions such as the Vancouver Aquarium to help make these connections—the whales and dolphins help us get that connection started.

### **Hana's Legacy**

- Last Thursday, under the leadership of Dr. Martin Haulena, a team of best-in-class veterinarians were flown in from across the continent to perform groundbreaking, emergency surgery on Hana. Despite these unprecedented efforts, Hana was unable to recover. She passed away on Sunday evening surrounded by the animal husbandry team who had been caring for her around-the-clock.
- For almost a decade, Hana has inspired and taught more than ten million visitors at the Vancouver Aquarium Marine Science Centre about her own and other ocean species. She also helped scientists learn more about dolphin biology and their conservation. Among the research projects she participated in are studies of energy requirements of Pacific white-sided dolphins, of seasonal resting metabolic rate and food intake, and of dolphin echolocation: to help researchers understand how they use their sonar to locate objects in the water. The discoveries from this latter study may one day help support cetacean-friendly fishing practices that will prevent dolphins from becoming entangled in nets in the future.
- Most recently, Hana participated in a lung-function study that may one day help inform marine mammal rescue efforts around the world, particularly during a mass stranding of cetaceans, which requires quick decisions to save sick and injured animals.
