I wanted to follow-up on our discussions about Passive House and was wondering if you, Bill, and whoever is in charge of new facility planning for Vancouver would be **interested in joining Gil Kelly (our GM Planning, Urban Design, and Sustainability) on a private tour of the Heights Passive House (Hastings at Skeena)** with the developer (8th Avenue) and builder (Peak Construction) of what will be Canada's largest passive house when it is completed this summer. They've been very generous with sharing their time and insights including why they have begun to pursue Passive House as a sound business decision for rental MURBs not only for this project but numerous projects across the lower mainland.

Gil will be touring the Project at **4:30 on April 4**. Hi Sadhu...noticed some of Councillor Reimer's tweets from the forum last night suggesting the City is waiting on the Province. Wanted to let you know the following new projects in the CoV were approved by the Province just yesterday:

VNHS - 285 E 5th Avenue 81 units plus new Indigenous school \$46.8M Red Door – 870 E 8th Avenue 51 units \$22.8M Atira – 420 Hawks 21 units \$5.9M

None of these are on CoV owned land or have VAHA involvement.

These are in addition to the almost 900 units under construction, the approval of the CoV projects on East Fraser Land (SUCCESS), Fraser Street (Community Land Trust) and the redevelopment of the city-owned Roddan Lodge not to mention the Masonic Lodge on Broadway, the redevelopment of the Stanley New Fountain Hotel and the purchase of the New Marr at Pender and Dunlevy. The Chinatown Foundation was able to close on the May Wah hotel in the past couple of weeks because of a \$6 million interest and payment free loan from the Province (the May Wah was previously under contract to a private developer) and the complete renovation of the Asia Hotel on Pender.

I am also pleased to let you know that the last SRO (Tamura Hotel on Powell) has been completed under the Provincial investment of \$143M to fully renovate and restore 13 SRO hotels comprising almost 900 rooms...all rents at \$375.

These are just off the top of my head...I am sure Mike can add to the list. Please feel free to share with Councillor Reimer.
