Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of March 28, 2017 for:

In relation to an event at Vancouver City Hall regarding changes and improvements to the permitting system for new houses and housing renovations held on April 15, 2016:

- Names of all persons attending the event (other than employees of City of Vancouver);
- 2. Names of all persons for whom city staff registered a reservation to attend the event (other than employees of City of Vancouver); and
- 3. Names of all persons who were thanked for their attendance at the event by an email last April 22, 2016.

All responsive records are attached. Some information in the records has been severed, (blacked out), under s.22(1) of the Act. You can read or download this section here: http://www.bclaws.ca/EPLibraries/bclaws_new/document/ID/freeside/96165 00

Please note, the spreadsheet contains a list of those companies/persons who were on the reservation list as well as how many individuals attended. The reservations were tracked through the Development Services generic email address and checked off as they came in the door (88 attendees who are not non-City Staff is the total count on the spreadsheet). However, if someone did not sign in or showed up late, it is possible they may not have been captured. If the City was provided with an email address, they were thanked for attending and sent a copy of the PowerPoint presentation from the event.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request. The Act allows you 30 business days from the date you receive this notice to request a review by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2017-128); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
